The Westerly 25' of Birch Avenue. Starting point is North of State Highway 191; thence North on Birch Avenue along Tract E, Tract 23, Tract 22, Tract 15, Tract 14 and Tract 7 to the SE Corner of Tract 5 in the Lionhead subdivision in the SE-1/4 of Section 23, Township 13 South, Range 4 East.

Gentlemen:

Since I will be unable to attend the hearing on the above petition due to the distance involved, I would like to invite the attention of the commissioners to the erroneous premises on which the Board of Reviewers based their recommendations.

My abstract of Lionhead Homesites indicates that Lake Ave., in that Subdivision, is 25 feet in width rather than 50 feet.

There is a road approximately 100 yards east of Birch Ave. running north from U.S. Highway #191 which has been in existence, to my knowledge, for over 20 years and which provides access to the lands to the east and north of the subdivision.

The purpose of Road Petition #680 is to protect the remaining trees on the west half of Birch Ave. from the depredations of the landowner to the east of the subdivision, Mr. Riley Carkeek, who has on several occasions, when I protested his removal of trees from Birch Ave. advised me he possessed a letter from the County Commissioners authorizing him to open any or all streets in the subdivision to the full platted width.

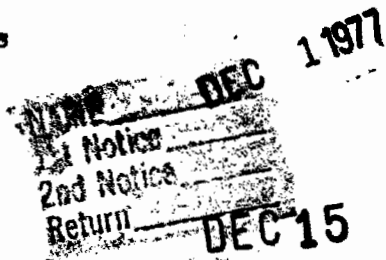
If the commissioners would care to comment on the above matters it would be appreciated.
