PETITION TO ABANDON COUNTY ROAD

Gentlemen:

We the undersigned Freeholders of Gallatin County, Montana taxable herein for road purposes, do hereby petition your Honorable Body to abandon as a County Road, Stiles #111 and being more particularly described as follows and shown in red on the attached plat:

Beginning at the SW 1/4, NW 1/4, SW 1/4 of Section 19, Township 2 North, Range 5 East; thence North 2466.5 feet; thence North 67° E 229.5 feet; thence North 55° W 262 feet; thence North 1013.7 feet; thence West on the North line of Section 24, Township 2 North, Range 4 East, for 5319.2 feet to the end of Stiles Road No. 111, which intersects with the Dry Creek Road.

Total distance 1.76 miles.

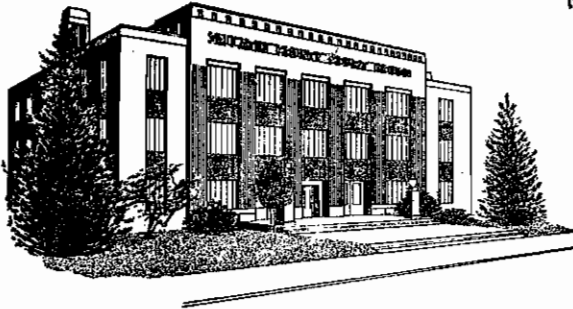

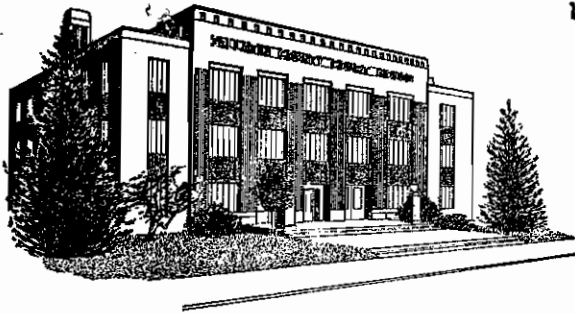
Unless a landowner or taxpayer wants to protest this petition you are not required to attend.
