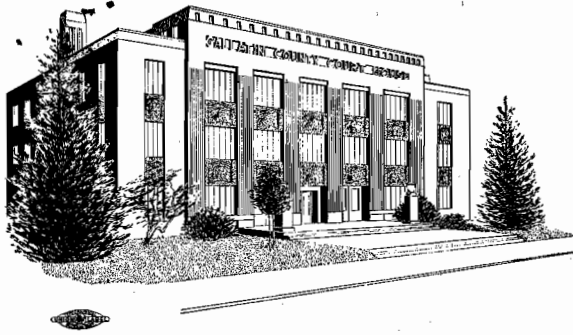

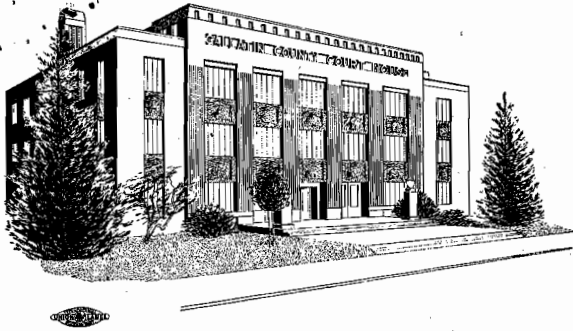

R E S O L U T I O N

This Resolution introduced by Commissioner Sager, who moved its adoption and was seconded by Commissioner Buttelman and was unanimously passed and adopted.

WHEREAS, the Gallatin County Commissioners acting pursuant to their authority granted by Section 11-2801 of the Revised Codes of Montana 1947, received a petition from property owners of Willow Creek, Gallatin County, Montana which asked for the abandonment of 2nd Street which is between Lot 7 in Block 3 and the north line of Block 8 in the original plat in the Community of Willow Creek in Section 19, Township 1 North, Range 1 East.

WHEREAS, the property owners, as petitioner, are the sole owners of any lots on the street which is to be abandoned.

WHEREAS, the Commissioners have determined that the street can be abandoned without detriment to the public interest.

WHEREAS, the County Commissioners have complied with the notice procedures of Section 11-2802.

WHEREAS, the Gallatin County Commissioners have held a hearing on the above-mentioned Petition on July 7, 1978.

WHEREAS, at the hearing on July 7, 1978, to consider the above-mentioned Petition to Abandon the Street between Lot 7 in Block 3 and the north line of Block 8 in the original plat in the Community of Willow Creek in Section 19, Township 1 North, Range 1 East, that there were no protests to the petition at the hearing.

THEREFORE, BE IT RESOLVED that the portion of 2nd Street between Lot 7 in Block 3 and the north line of Block 8 in the original plat in the Community of Willow Creek in

Section 19, Township 1 North, Range 1 East be abandoned.

IT IS FURTHER RESOLVED that the portion of the abandoned road north of the centerline revert back to owners of adjacent property, the Park brothers, and that the portion of the abandoned road south of the centerline revert back to owner of adjacent property, Molly McLean.
