Gallatin County, Montana

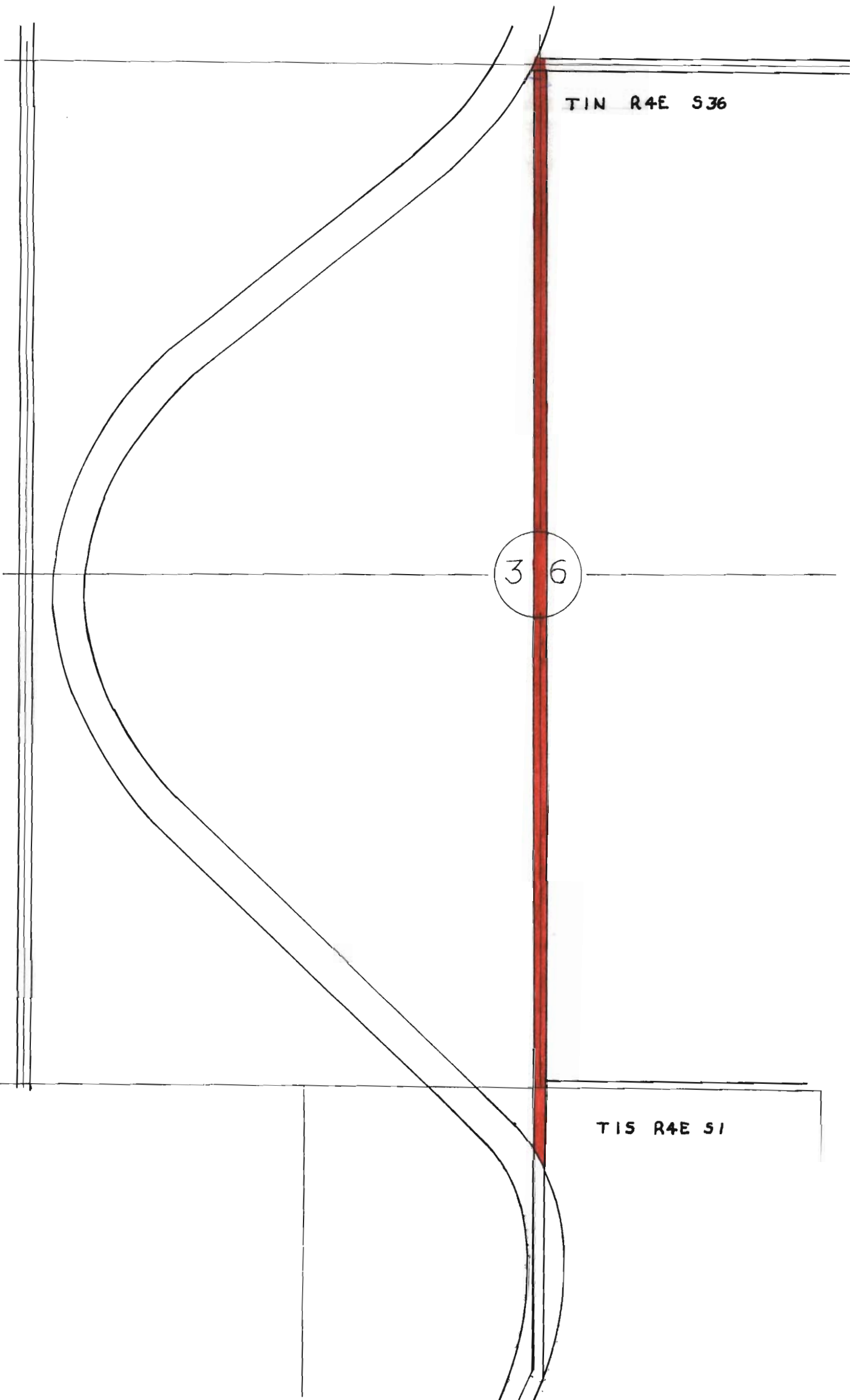

Beginning at the North quarter corner of Section 36, Township 1 North, Range 4 East where the old road intersects the new road, thence South to the South quarter corner of Section 36, Township 1 North, Range 4 East; thence South through Section 1, Township 1 South, Range 4 East to the right-a-way of new road in Section 1, Township 1 South, Range 4 East.

Plat attached showing road to be vacated in red.

Total distance 1.2 miles more or less.
