Dear Commissioners:

I have been asked to write down the past history of Canyon View Road as I remember it. We have lived on the road since Nov., 1956 and in the present house since 1958. Our address is 770 Canyon View Road.

The road was graveled when we moved there but several places the gravel was not deep enough to prevent deep ruts after the spring thaws. The first winter the county snowplow opened the road and I believe I still have a colored slide of the patrol shoving snow. As I remember it the county patrol made a couple of trips over the road each year.

The year the interstate was built up Rocky Canyon Jack Hallam, Rusty Ralston and I purchased surplus gravel from the County yard. This gravel contained more large rocks than they wanted to put on other roads and we paid a minimum charge for the gravel and hauling. This material was just what we needed because we have not had the frost boils since.

That same year we contracted with the gravel contractor on the interstate for over 200 yards of crushed limestone plus smoothing and packing. At the time the county road department agreed to maintain the road now that we had it up to shape, however the state assumed the maintenance of the access road from Canyon View Trailer court to the county road at the Bear Canyon access. The road department informed us they were unable to cross our bridge on Bear Creek and it was too far for them to come down the access road to maintain our road.

We have not had any county equipment on this road since that time. From time to time a number of us have purchased gravel from the commercial suppliers and hired the Mount Ellis Academy patrol to smooth the road. The Academy patrol has been broken down from time to time and the present administration has not been inclined to help us out. Also, we've been waiting for some of the non-paying neighbors to get in gear.

Clarence Finch, the owner of the house we now own, said the road had been dedicated and was a county road but I can not verify this. I do know the county granted Montana Power the easement to put in the natural gas line about 1954-55.

All of us would appreciate some help in smoothing the road as the Mail Carrier has threatened to force us to get our mail out on the access road because the road is so rough. The Sheriffs patrol goes down our road and I'm sure they would appreciate a smooth road, I know we appreciate their patrol.

In the winter of 1967 the County roadgrader came out and removed our snow and all of a sudden they quit maintaining our road. We the taxpayers could never figure out the why to this decision. We, the undersigned know that this happened.

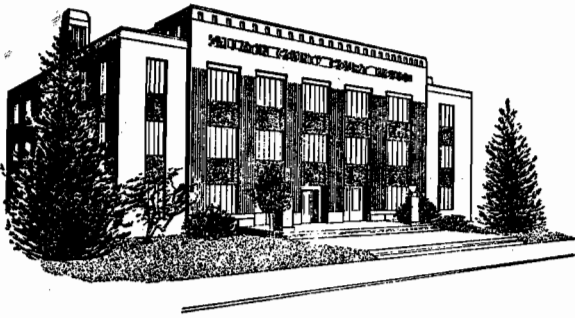

INVESTIGATION REPORT PETITION 702

On Sept. 19, 1980, Commissioner John Buttelman and County Surveyor Robert Babb viewed the described section of roadway in Petition 702.

The oiled section of Frontage Road extends from the Bear Canyon Interchange of I-90 to the East end of a "dedicated lane for public use" (Moriarty Subdivision filed - December 1951). This petition then requests the "opening" of this "dedicated lane" along with the "dedicated lane" on the West side of Moriarty Subdivision. It is my belief that these lanes became "dedicated for the public use forever" at the filing of this subdivision map and therefore have the status of "public roads" at this present time. (Section 7-14-2112 MCA 1978) (1) the width of all county roads, -- must be 60 feet--. If these lanes are to be established as "county roads" additional right-of-way will have to be obtained. This 60 foot right-of-way would require the possible taking of portions of existing houses and garages.

(Section 7-14-2602 contents of petition)

The petition must set forth:

- (2) The general route thereof;
- (3) The lands and owners affected.
- (4) Whether the owners who can be found thereto.
- (5) Where consent is not given, the probable cost of the right-of-way.
- (6) The necessity for and advantage of the petitioned action.

I can not find that this petition has met any of these 5 requirements.

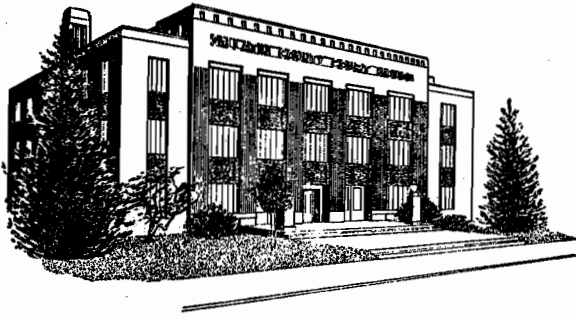
Therefore, I must submit my recommendation that the demerits of the petition far outweigh the merits of the petition and believe the Board of County Commissioners should deny this petition.
