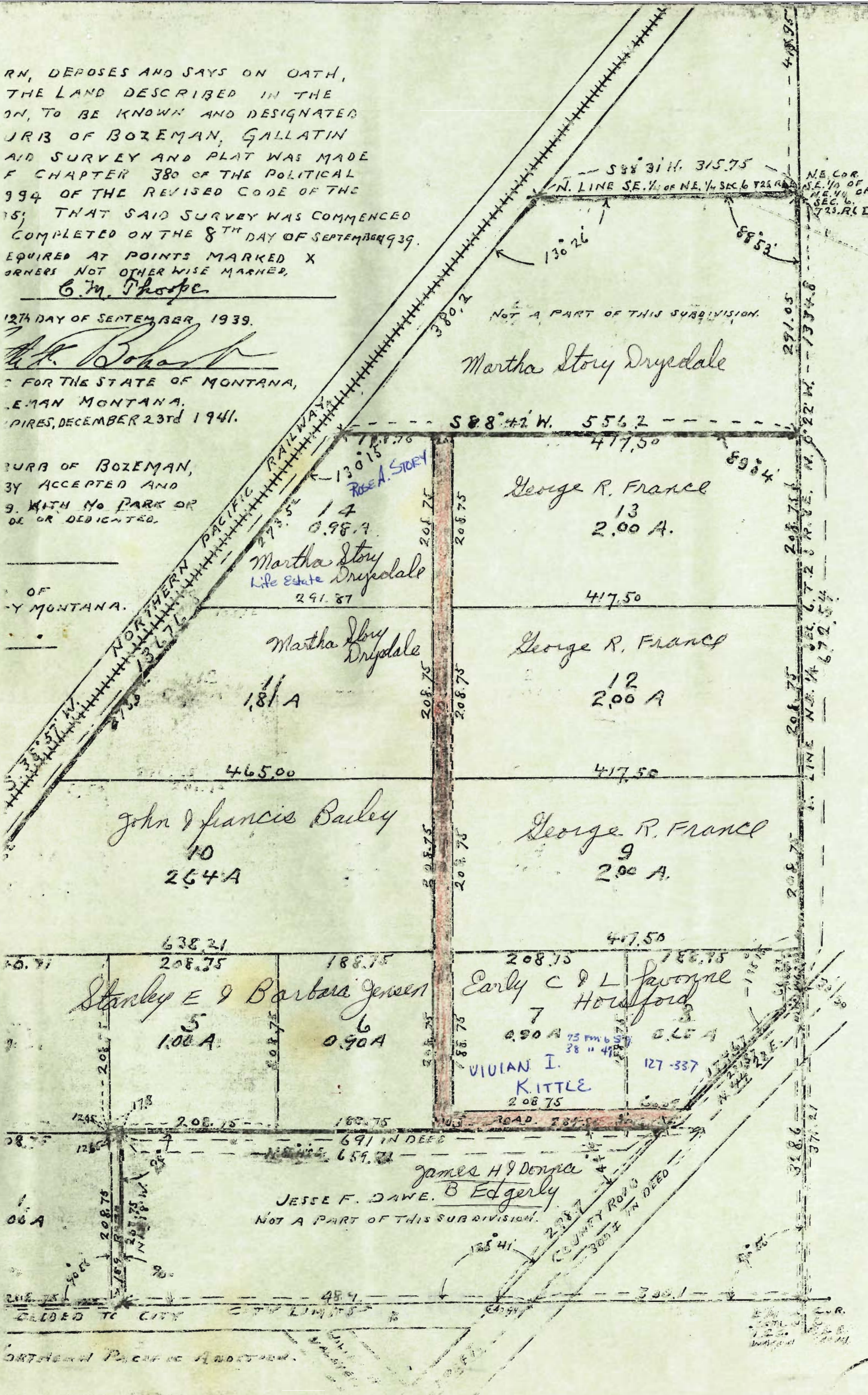

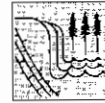
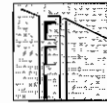

I am writing with concern about the proposed abandonment of the existing public road serving the Paradise Vista Subdivision No. 3.

As you are probably aware, a proposed sewer main is planned to be constructed within the right-of-way of the roadway in question. This proposed routing along this roadway is, from an engineering standpoint, the best possible alignment. This proposed sewer main would also provide sewer service to the Paradise Vista Subdivision, an area which is presently utilizing septic and drainfield systems which are troubled by high ground water.

This sewer main has the potential of serving a great deal of property. I have enclosed the sewer service area plan as approved by the City of Bozeman.

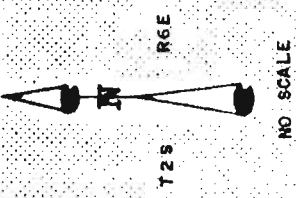
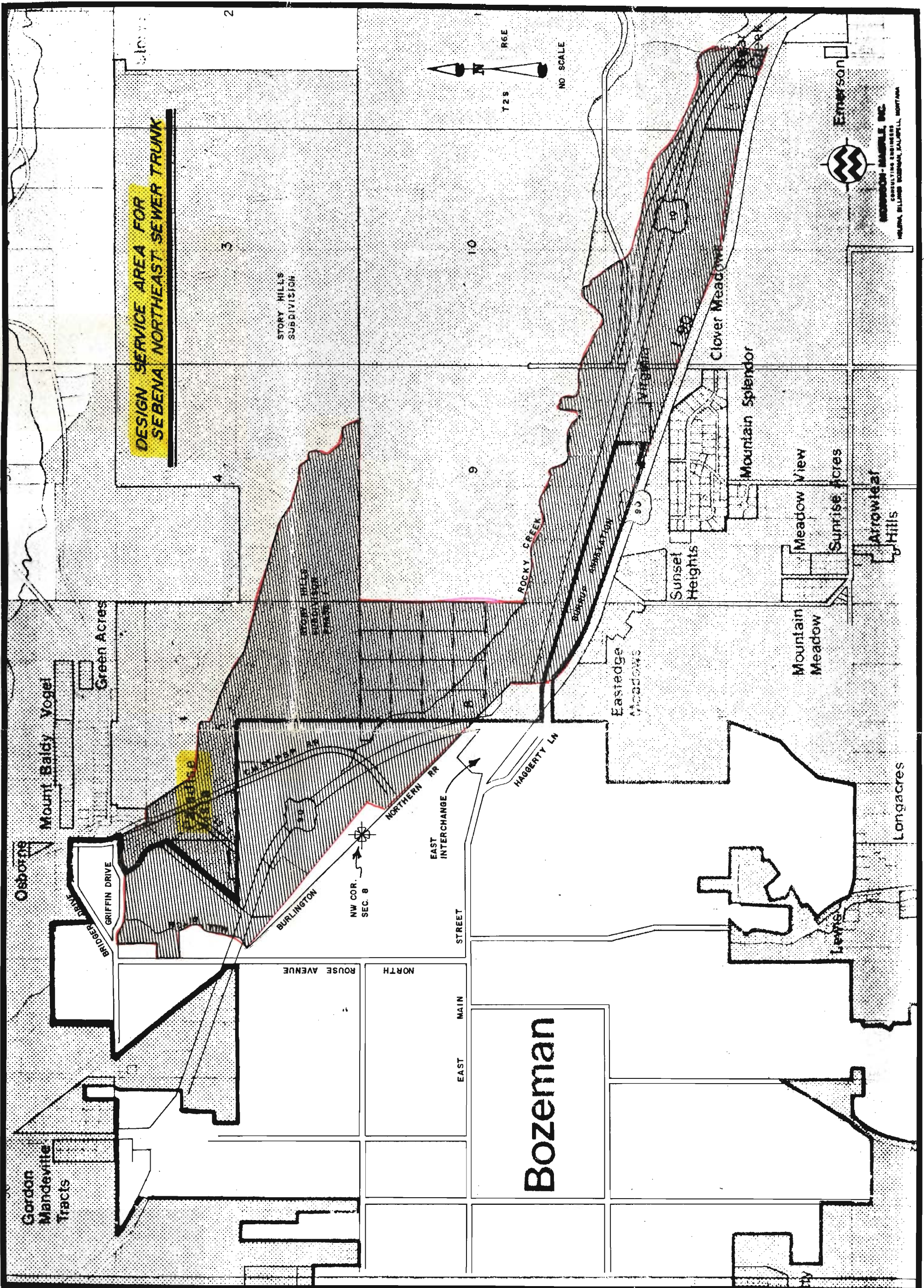


