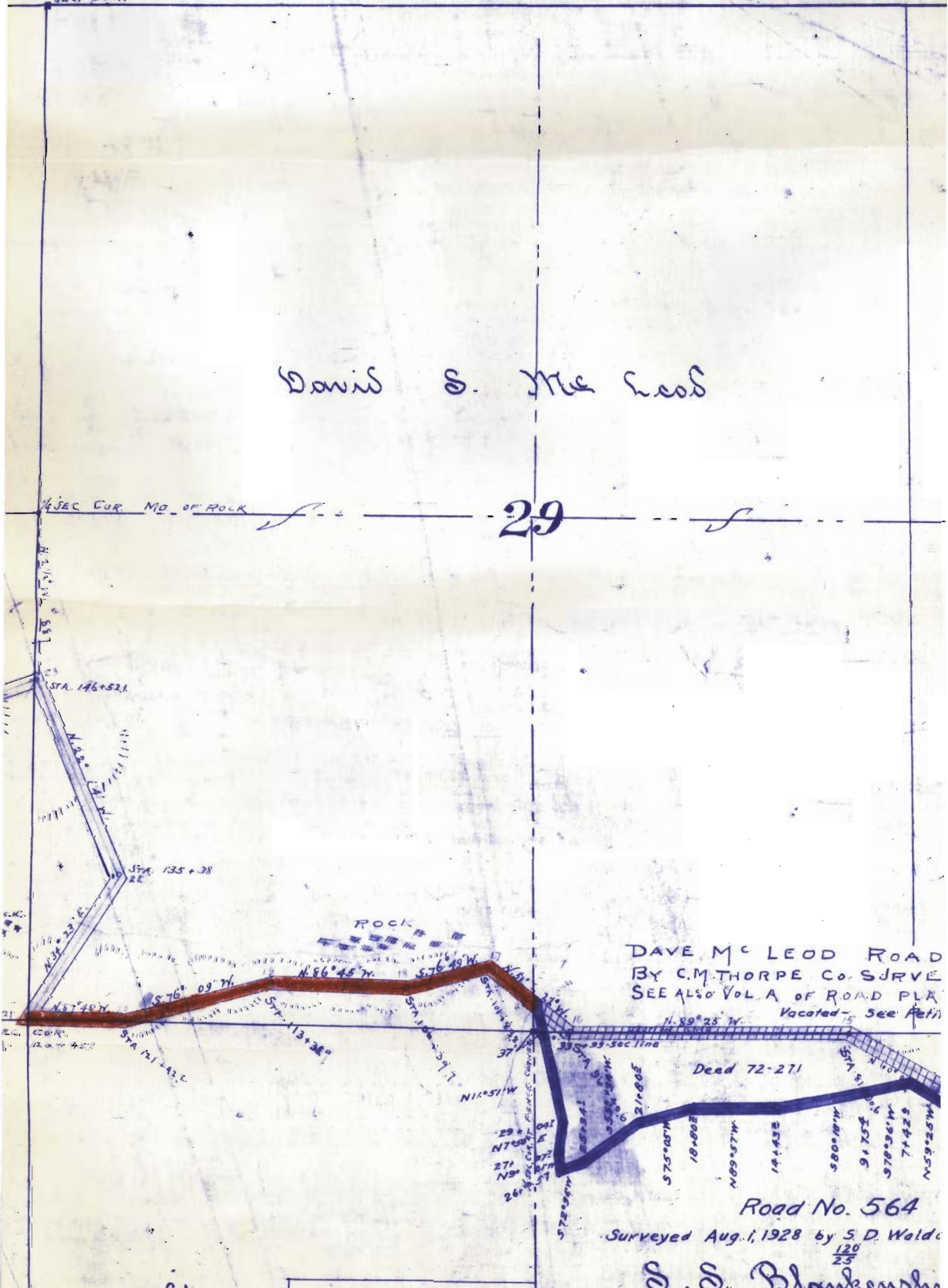

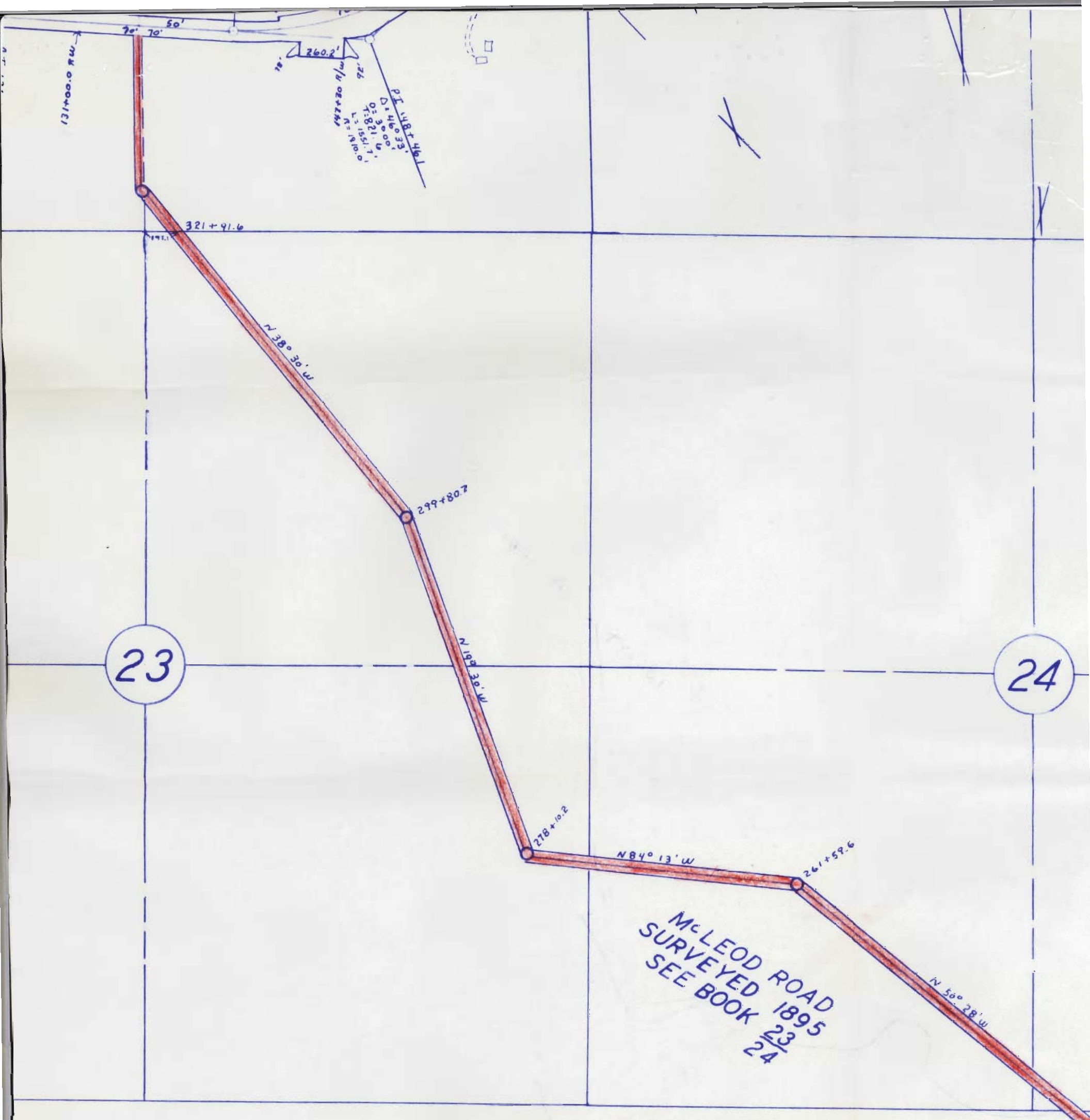
DAVE MC LEOD ROAD
