PETITION TO ABANDON COUNTY ROAD

To the Honorable Board
of County Commissioners

Dear Members:

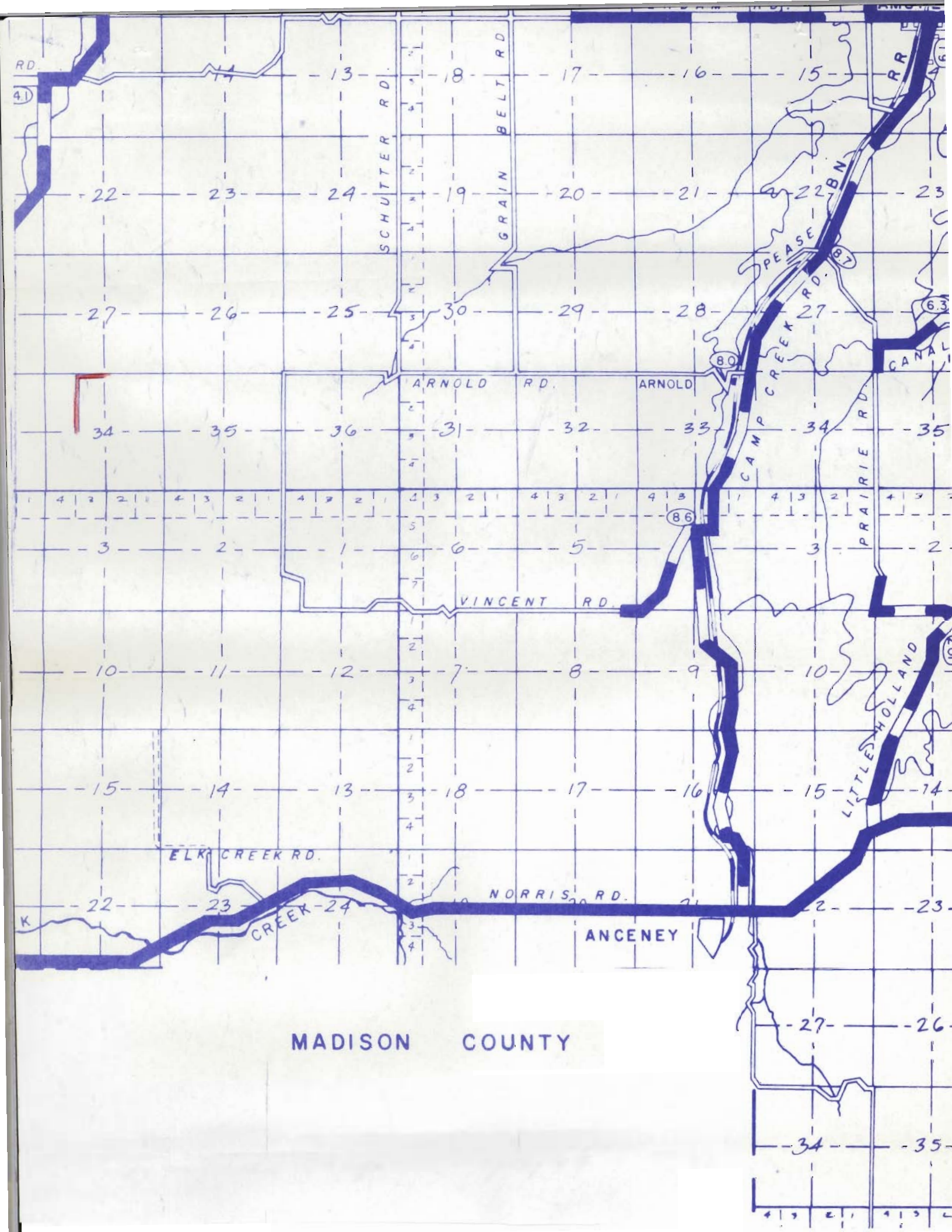
We the undersigned Freeholders of Gallatin County, Montana taxable herein for road purposes do hereby petition the Board of County Commissioners, pursuant to Section 7-14-2601, MCA to abandon a county road, being more particularly described as follows:

Beginning point to abandon 60' wide county road number 231 is at the North quarter corner of Section 34, Township 1 South, Range 2 East; thence West 1320 feet more or less to the West sixteenth corner of Section 34, Township 1 South, Range 2 East, thence South ½ mile to the center-west sixteenth corner of Section 34, Township 1 South, Range 2 East.

Total distance of county road to be abandon is 3960 feet more or less.

- (1) Road to be abandoned is shown in red on the attached drawing.
- (2) The necessity for and the advantage of the petitioned action as described above are as follows:
 - a. The road has never been constructed.
 - b. This road is isolated with no county roads adjoining.
 - c. To remove the road from county system.


Total distance of county road to be abandon is 3960 feet more or less.
