Dear Members:

We the undersigned Freeholders of Gallatin County, Montana taxable herein for road purposes, do hereby petition the Board of County Commissioners, pursuant to Section 7-14-2601, MCA to abandon a portion of county road which has never been constructed or named and being more particularly described as follows:

Starting point is west  $\frac{1}{4}$  corner of Section 29, Township 3 South, Range 5 East;  
thence South 117 feet;  
thence South 54° East 795 feet;  
thence South 37°30' East 206 feet;  
thence South 43°45' East 704 feet;  
thence South 14°55' East 420 feet;  
thence South 39°55' East 445 feet;  
thence South 11°55' East 212 feet;  
thence South 37°35' East 138 feet;  
thence South 65°20' East 168 feet;  
thence South 19°05' East 113 feet;  
thence South 58°50' East 220 feet;  
thence South 70° East 116 feet;  
thence South 59°50' East 106 feet;

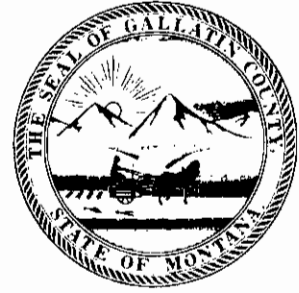
