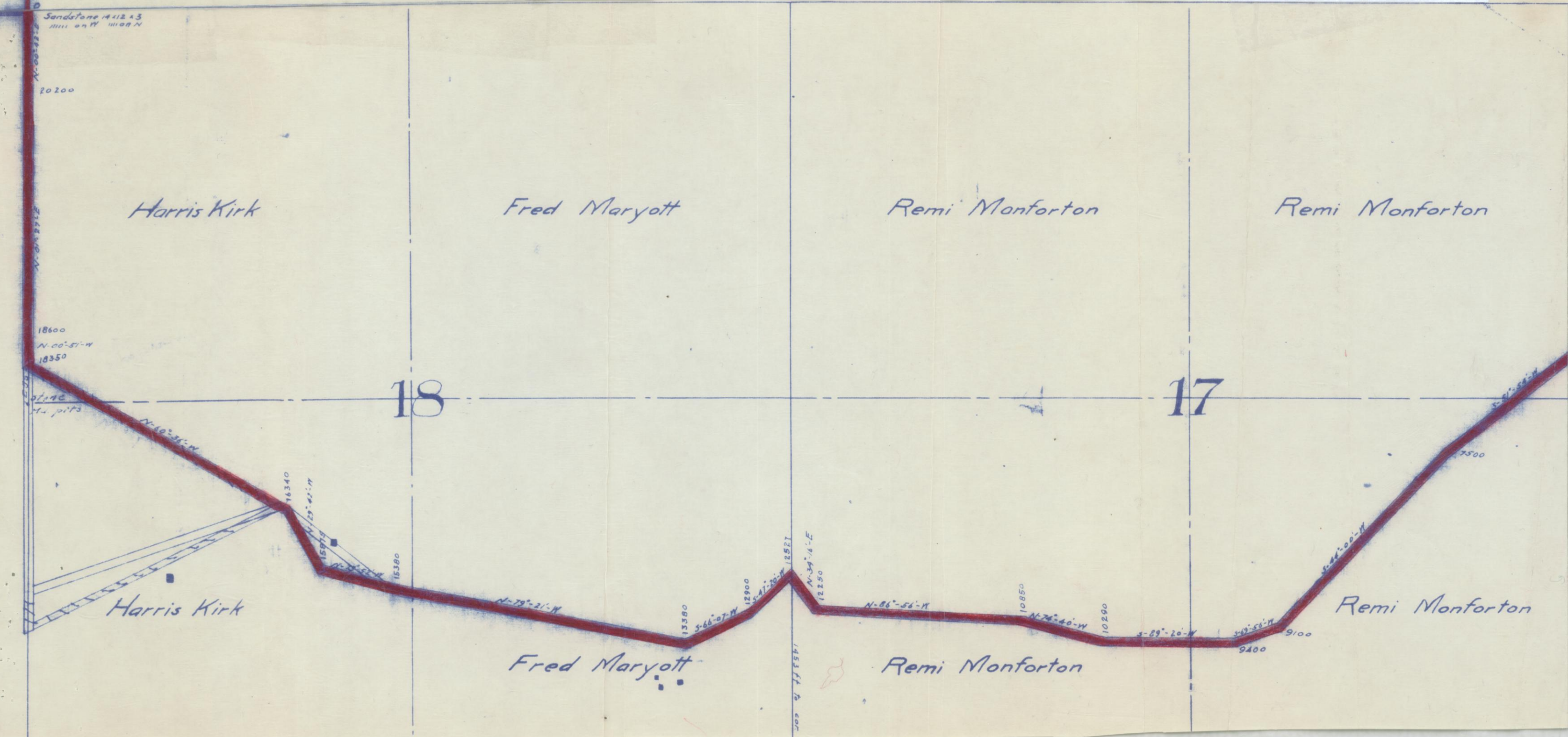
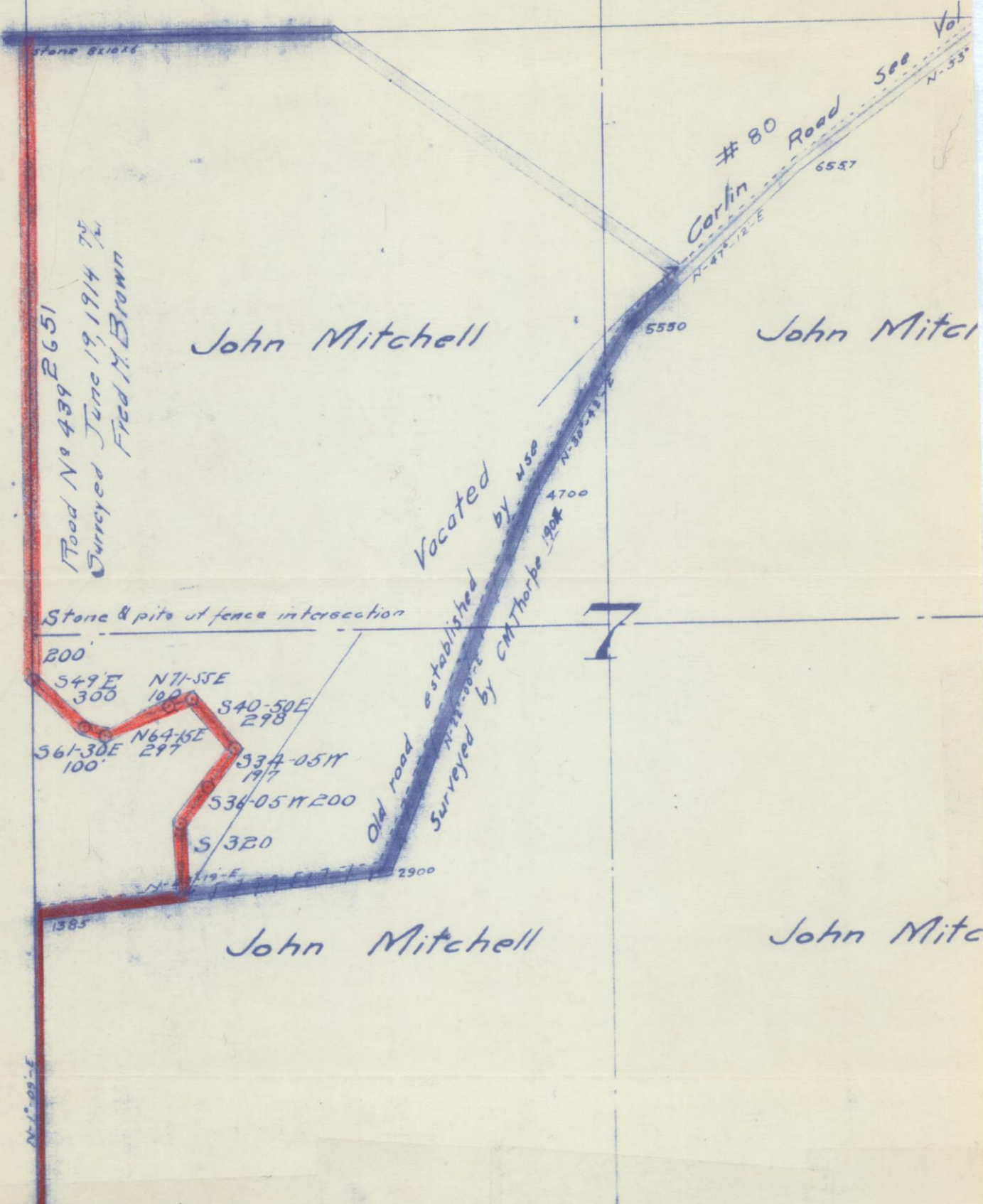
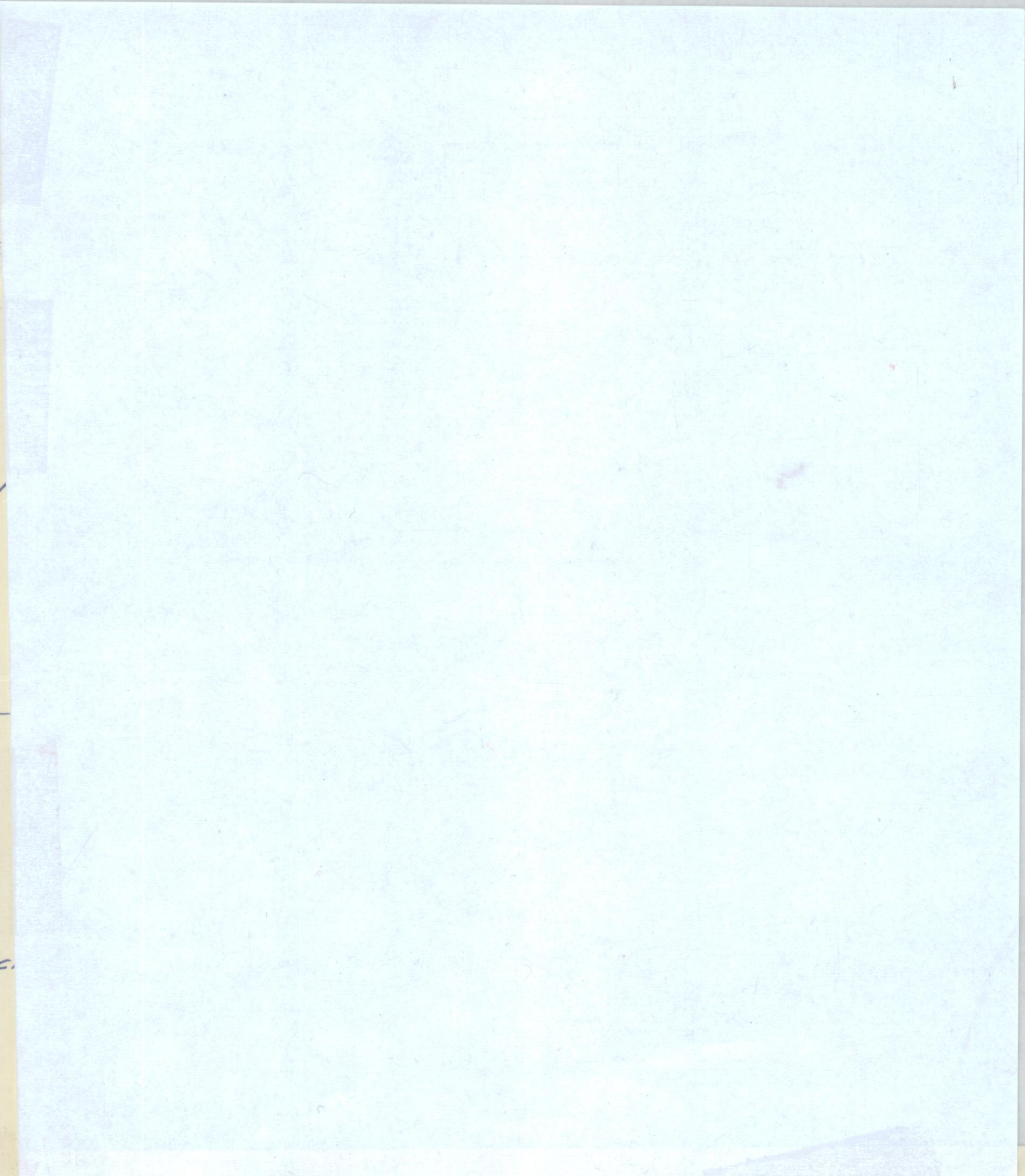

Dear Board:

On February 4, 1988, the undersigned, being duly appointed as viewing committee viewed and considered that portion of Gateway-Foothills Road to be abandon.

The viewing committee recommends that only that portion of Gateway-Foothills Road lying within Section 7, Township 3 South, Range 4 East M.P.M. and that portion of the road which follows the North-South Section line between Sections 7 and 18, Township 3 South, Range 4 East M.P.M. and Sections 12 and 13, Township 3 South, Range 3 East M.P.M. be abandon. That portion of the road has never been maintained and is impassable when wet. The Sections of land affected would be served by the Axtell-Anceney Road and the remainder of the Gateway-Foothills Road.

The viewing committee recommends that the remainder of Gateway-Foothills Road that was petitioned to be abandon remain open as it provides access to land that would otherwise have no access and the county already maintains that portion of the road.

Mr. Schunke stated an information sheet was attached to the creation petition which summarized the information.

The Commissioners stated receiving a total of 7 phone calls regarding the creation of the proposed RID and all were information inquiries.

Ramon S. White explained to the public that the County's notification process is governed by State Statute and that the Clerk and Recorder did complete the proper notification with regards to posting, publication, and mailing as required by State Statute.

Wilbur Visser stated that there were not enough protests received to stop the creation of the proposed RID. Jane Jelinski read Resolution #715 creating RID #342. Motion by Jane Jelinski to adopt Resolution #715 creating RID #342 in Wheatland Hills. Seconded by Ramon S. White. None voting nay. Motion carried.

- - - -

Wilbur Visser stated receiving the Affidavits of Posting, Publication, and Mailing, and stated the close of the protest period was March 10, 1988 regarding the creation of RID 343, Pinview Subdivision. Mr. Visser stated receiving a letter from the Clerk and Recorder Gerald R. Wine, stating 1 valid protest and 1 protest letter received after the close of the protesting period. There was no public testimony. Wilbur Visser stated that there were not enough protests received to stop the creation of the proposed RID. Motion by Jane Jelinski to adopt Resolution #714 creating RID #343 in Pinview Subdivision. Seconded by Ramon S. White. None voting nay. Motion carried.

- - - -

Wilbur Visser stated receiving the Affidavit of Publication and receipt of certified letters, and petition regarding the proposed abandonment of Gateway Foothills Road. Wilbur Visser read the viewer's report. [see road petition #725 filed in the Clerk and Recorder's Office]

Gale Thompson, Road Office Superintendent, explained the viewer's report recommends the west portion of road which runs north and south in Sections 7 and 12 and 18 and 13 be closed and the south portion of road which runs east and west in Sections 17 and 18 remain open.

Amber Hargrove, protested the closure and stated that Edith Dornbos and Dr. Norman Kenck and his two partners had not been notified of the proposed closure. Also protesting were Gene Hawks, of the Public Lands Access of the State of Montana, and Joe Gutkowski, State Director of Montana Wildlife Association.

Dick Day, Bill Asher and Walter Steingruber spoke in favor of the proposed closure because of being private landowners bordering the road and having problems with poaching, hunting without permission, fence cutting, and people with RV's ruining cropland and roads. Mr. Asher also offered to grant an easement to Hargroves and Dornbos for access to their cabins.

Ramon S. White stated, as a member of the viewing committee, the reason a portion of Gateway Foothills Road proposed abandonment was reduced was because Sections 17 and 18 do not have any access and stated the State Sections and Federal Lands did not come into the viewing committee's considerations because those areas are miles away and have nothing to do with public land access.

Jane Jelinski explained that because of Amber Hargrove's statements regarding Dornbos and Kenck not being notified of the proposed abandonment that she feels it critical that the Commission has assurance that all people have been notified and have the opportunity to respond to all or part of the proposal because of the legality of the process and suggested postponing a decision for a week or two.

Ramon S. White supported the viewing committee's recommendation and stated Dornbos and Hargrove had been offered a granted easement and knew that Dr. Kenck would only use the Gallatin Gateway access.

Motion by Ramon S. White to abandon a portion of Gateway Foothills Road as recommended by the viewing committee. Seconded by Wilbur Visser. Ramon S. White and Wilbur Visser voting aye. Jane Jelinski voting nay. Motion carried.

Ramon S. White read Ordinance #88-1 imposing truck speed limits on County roads. Wilbur Visser explained that this was the first reading of the proposed Ordinance and the second reading will be read March 29, 1988. Motion by Ramon S. White to adopt Ordinance #88-1 imposing truck speed limits on County roads. Seconded by Jane Jelinski. None voting nay. Motion carried.


