That portion of alley which is 20 feet wide that lies between amended Certificate of Survey D43-A, tract A and lots 88, 89, 90, 91, 92, 93, 94, 95, and 96 in the Rainbow Subdivision in Section 14, Township 2 South, Range 4 East.

Reason for abandonment of above described alley is as follows:

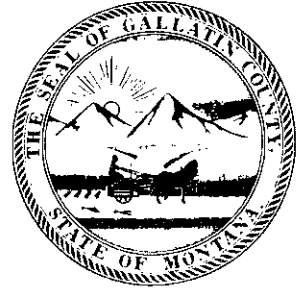

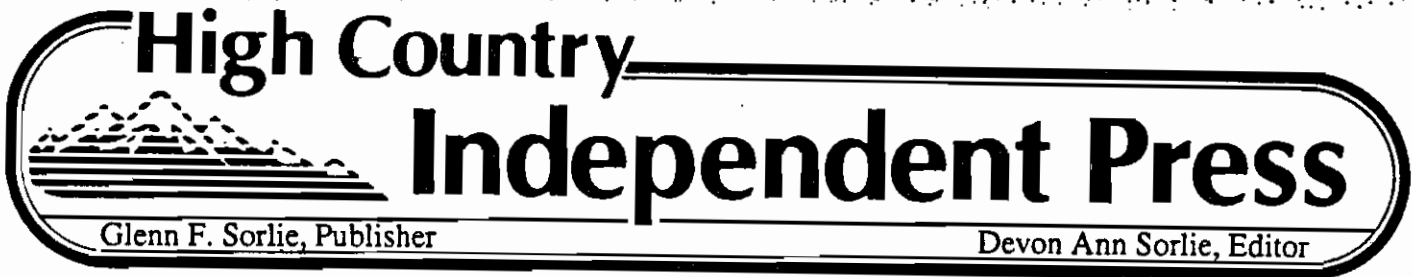

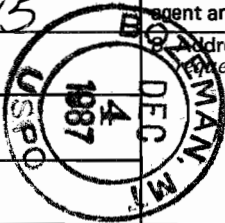
