Dear Sirs:

As members of a coalition of your constituency, we are respectively submitting this petition.

To Wit:

We, the undersigned, do petition the Gallatin County Commissioners to extend the east end (dead end) of Stagecoach Trail Road south to include that portion of an established and well maintained road, also known as Stagecoach Trail Road, up to and including the approach and intersection to the Amsterdam Road, a paved blacktop, a distance equal to approximately one (1) mile.

This proposed extension consists of an established roadway which has been built to equal or exceed the specifications of the County maintained section of Stagecoach Trail Road and, for the past several years, has been maintained by the members of the Road Association which border said road. The condition of said extension often surpasses the condition of many "county maintained" roads. Given these circumstances, the County would encounter no expense to build such an extension.

This petition requests ONLY that Gallatin County maintain the ENTIRE length of Stagecoach Trail Road, of which the additional cost of 1 mile would be negligible.

All landowners bordering the road are requesting this be accomplished, as the road has become a major through-access road by the public at large, many of whom assume this section to be included in the County Road system.

The one exception to this seems to be the Manhattan School bus, which presently makes a dead end U-turn at the point of intersection of these two portions of road. Several children access this bus, which is prohibited to create a "loop" merely because of the status of the 1 mile section in question. We feel that significant mileage can be saved by not "backtracking" and the students would greatly benefit by increased access to the bus route.

In light of the Revised Codes of Montana, as follows, we believe the Board is legally and morally obligated to perform their duties as requested by the landowners and tax payers in support of this petition.

7-14-2103. Duties of county commissioners concerning county roads. (1) Each board of county commissioners has general supervision over the county roads within the county.

(2) Each board shall survey, view, lay out, record, open, work and maintain county roads which are petitioned for by freeholders. Guideposts shall be erected.

7-14-2111. Layout of roads. County roads must be laid out and opened when practicable upon subdivision or section lines. However, when public purposes shall be best served thereby, roads may be laid out in diagonal lines.

7-14-2113. County authority to establish speed limits. A board of county commissioners may, by ordinance, establish a special speed limit in accordance with 61-8-306 and 61-8-310 on any county road.

7-14-2122. County road supervisor. (1) Each board of county commissioners may in its discretion employ a competent road supervisor, who shall serve during the pleasure of the board. In any county in which the county surveyor is not paid an annual salary, he may by agreement be employed by the board to perform the services of road supervisor. He shall not be paid for any duty otherwise required by law to be performed by him as county surveyor.

(2) Under the direction and control of the board, he shall: a) prescribe the times and places for all work to be done on the county road; b) report any delinquency or inefficiency of any person employed on any road.

7-14-2514. Limit on expenditures for road district. (1) The expenditures in any road district for labor and equipment, together with the compensation to be paid to the supervisor, shall not exceed the sum apportioned quarterly by the board of county commissioners to that district. However, if that sum is not sufficient, the board may appropriate any amount from the county road fund necessary for the use of such district.

(2) The full amount of all road taxes collected in remote districts shall be expended annually by the county commissioners on the roads within such districts.

7-14-2601. Petition to establish, alter, or abandon a county road. (1) Any 10, or a majority, of the freeholders of a road district taxable therein for road purposes may petition the board in writing to open, establish, construct, change, abandon, or discontinue any county road in the district. (2) When the road petitioned for is on the dividing line between two counties, the same procedure must be followed except that a copy of the petition must be presented to each board. The two boards shall act jointly.

7-14-2602. Contents of petition. The petition must set forth: (1) the particular road or roads to be opened, established, constructed, changed, abandoned, or discontinued; (2) the general route thereof; (3) the lands and owners affected; (4) whether the owners who can be found consent thereto; (5) where consent is not given, the probable cost of the right-of-way; (6) the necessity for and advantage of the petitioned action.

7-14-2603. Investigation of request concerning road -- decision. (1) At its next regular or special meeting or in any case at a date within 30 days after filing of any petition, the board shall cause an investigation to be made of the feasibility, desirability, and cost of granting the prayer of the petition. The investigation shall be sufficient to properly determine the merits or demerits of the petition. (2) No more than one member of the board and the county surveyor shall make the investigation. (3) After considering the petition and the results of the investigation, the board shall make an entry of its decision on the minutes.

7-14-2604. Notice of decision on petition. Within 10 days thereafter, the board shall cause notice of its decision to be sent by certified mail to all owners of land abutting on the road petitioned for. The owners shall be those listed on the last county assessment roll.

7-14-2605. Opening of county road. If the petition is for the opening of a county road and the board grants the prayer ordering the road opened, it shall proceed at once to have it opened to the public and declare it to be a county road.

7-14-2611. Alteration of road to follow subdivision or section lines. (1) A majority of the freeholders or owners residing on a county road or portion thereof may petition the board in writing to so change the road or portion as to run on subdivision or section lines. (2) The board shall investigate in the same manner as provided in 7-14-2603. After investigation, the board may order the making of the change if it can be done without material damage, injury, or serious inconvenience to the public customarily using the road or portion. (3) Those petitioning for the change shall bear all or such portion of the cost and expense of making it as the board may order.

7-14-2613. Notice to district supervisor of opening or alteration of county road. When a county road is to be opened, established, constructed, changed, abandoned, or discontinued, the county clerk shall notify the supervisor of the proper district and furnish him with a certified copy of the order of the board.

7-14-2614. Record of road opening or alteration to be maintained. When a county road is opened or changed, the findings of the board, the plat field notes, and the report of the surveyor shall be recorded in the office of the county clerk in a book kept for that purpose.

We believe our request is well founded and, in the event favorable action is not taken, we will petition the court to ask the board to show cause why these duties cannot be performed.

Rather than interpret the above statement as a threat, please consider it as our determination to see Stagecoach Trail Road maintained by the County IN ITS ENTIRETY.

A previous effort of a vocal hearing, and represented by an attorney for our Road Association attempting to accomplish this small request, brought the following results:

1. Two traffic counters were installed in each end of the proposed extension. The road supervisor placed the hose sensors in from 4-6 inches of snow; the temperature being from 5-14 degrees below zero, resulting in inaccurate and incomplete traffic count reading.

2. NO joint investigation by a member of the board and the supervisor. (RMC 7-14-2603)

3. NO entry in the minutes. (RMC 7-14-2603)

4. NO notice within 10 days to owners of land abutting the road indicating the boards decision on said petition. (RMC 7-14-2604)

5. NO action taken. (RMC 7-14-2103, Section 2)

The decision to submit this petition in the form of an open letter to the county commissioners via the Bozeman Chronicle was considered and rejected at the present time as being unfair to certain board members.

ADDENDUM

As an added comment, however, not a portion of this petition. Many people in this county are disappointed in the performance of past county commissioners. The lack of supervision of county employees (RMC 7-14-2122), poor systems management, unequal road maintenance in various areas and the disappearance of large sums of money all effected the road operation and road budgets.

We believe that if all major expenditures and salaries of foremen and supervisors were published, along with the income the county receives involving county roads, and periodic audits by independant firms, the people would accept the often stated phrase "We don't have the money." Refer to RMC 7-14-2514 (2).

The viewing committee observed the following:


1. Portions of the road do not meet county standards.
2. Traffic on the road does not seem to warrant county maintenance when comparing it with other county road systems and their traffic patterns.


The viewing committee has the following comments:
