The alley between Reinig Street and Penwell Street in block 2 of the unincorporated townsite of Central Park, 16 feet wide x 670 feet long.

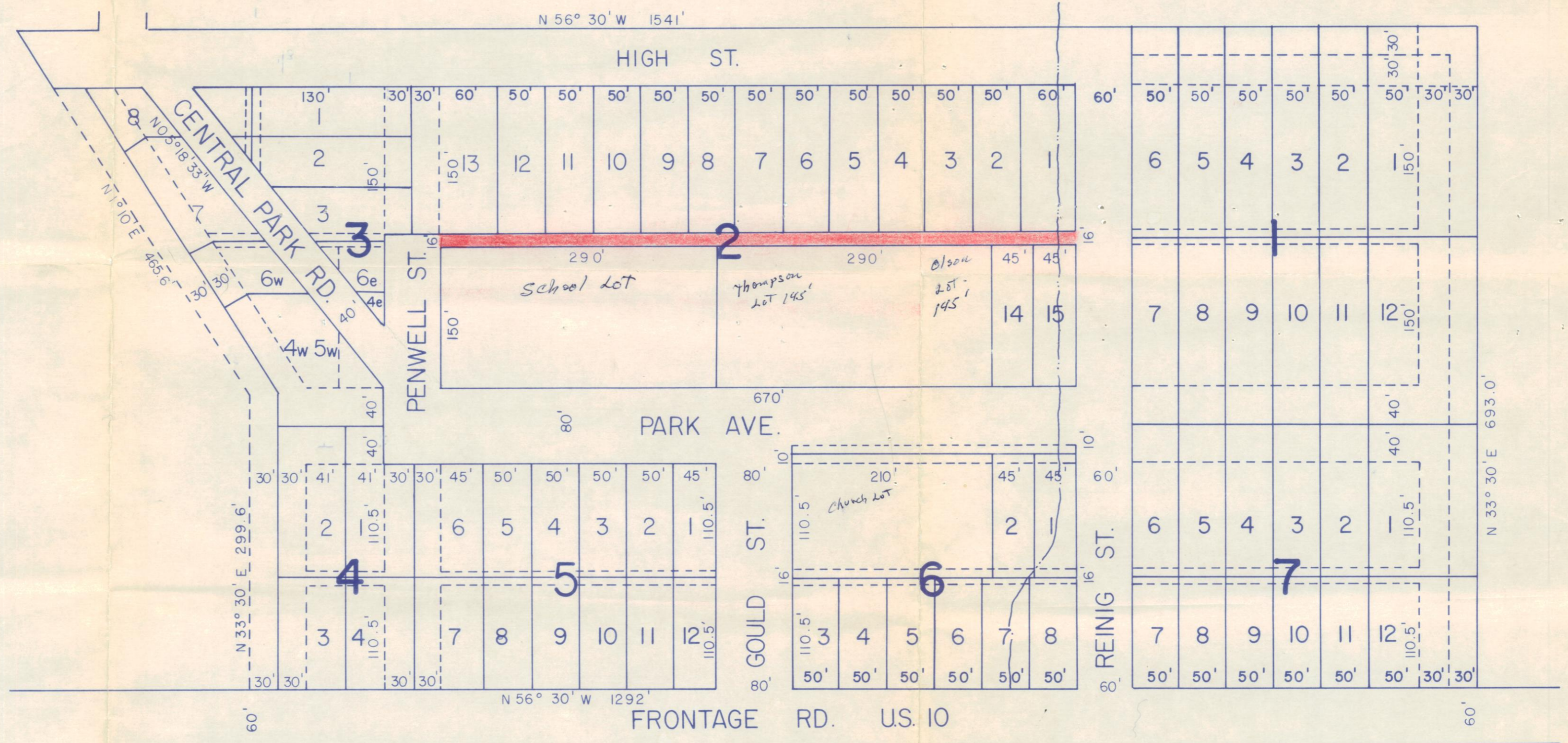
1. Total distance to be abandoned 670 feet.

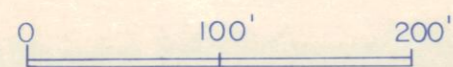


Dear Board;

On April 25, 1991, the undersigned, being duly appointed as viewing committee, viewed the alley located in Block 2 of the Townsite of Central Park in Section 19, Township 1 North, Range 4 East, M.P.M., Gallatin County, Montana, which has been petitioned to be abandoned by road petition #742.

The viewing committee observed the following:

1. The alley has not been constructed.
2. The viewing committee witnessed survey stakes located on one of the lots which allowed us to determine that some buildings are located on the alley including one large barn, 2 outhouses, and utility poles located on the northern side of the alley.

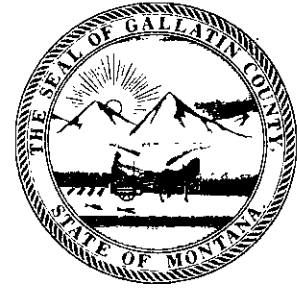


