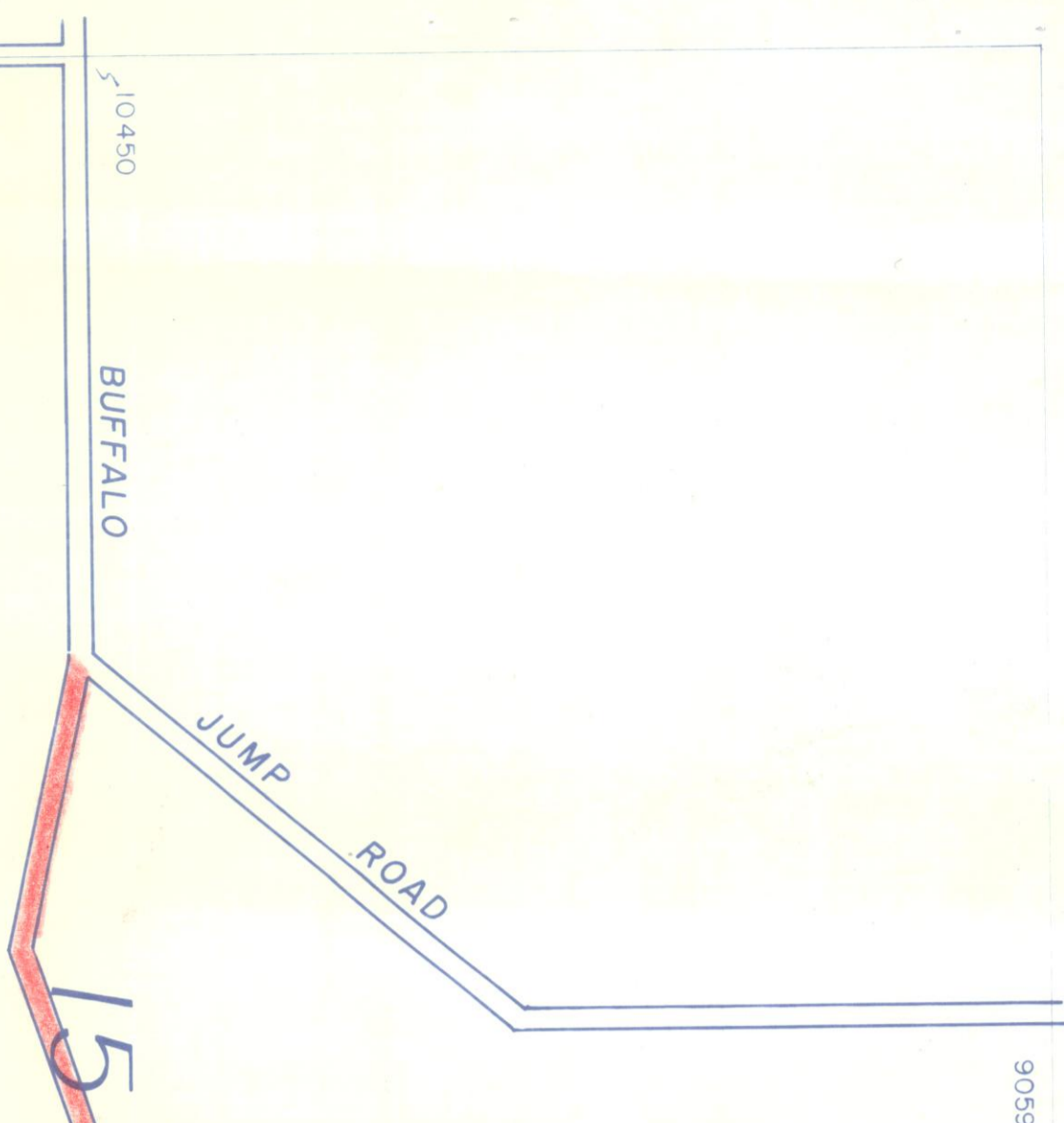



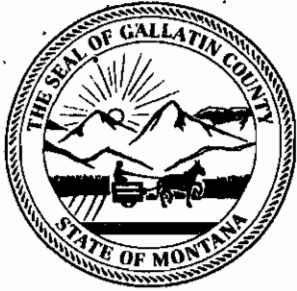


RESULTS OF RESEARCH OF PROPERTY OWNERS:




The following was observed by the viewers committee on July 8, 1991 as a result of a petition to abandon a portion of Amsterdam Road: from the Northwest Quarter Corner of Section 13 T1S, R2E; South 0o26" 1760 feet to the point of beginning; Thence South 25o16' West 549 feet; thence South 61o13' West 445 feet/ thence South 71o50' West 590 feet; thence North 77o53' West 2031 feet; thence North 36o19' West 234 feet; thence South 37o55' West 305 feet; thence South 21o25' West 89 feet; thence South 14o45' West 163 feet; thence North 88o53' West 188 feet; thence South 69o48' West 335 feet; thence South 87o48' West 660 feet; thence North 71o45' West 355 feet; thence South 66o49' West 555 feet; thence North 79o09' West 848 feet.

Observations:

1. Approaching from the east the existing built county road ends at a cultivated field where it is no longer possible to see the extension of the road, and not possible to access the remainder of the road.
2. No survey markers to discover the actual location of the road presently exist.
3. At the end of the built portion of the road is a "No Trespassing" sign.
4. The eastern built portion of the road is a dirt road, which diminishes to a two-path field road.
5. Approaching from the west from Buffalo Jump Road the road is visible as a road cut, but is overgrown with grass and weeds.
6. We were able to follow the primitive road cut up a hill through a gully and drive to the west end of the cultivated field we had previously observed from the east (1-4). It was our estimate that about 1/4 to 1/2 mile of the non-visible portion of the road passed through the fields.
7. The overgrown portion of the road from the west is about 5700 feet from Buffalo Jump Road to a gate opening onto the cultivated field - this part is difficult to build to County standards.

The roadway to be abandoned is more particularly described as follows:
