PETITION TO ABANDON A PORTION
OF SCHUTTER ROAD

To the Honorable Board of
County Commissioners
Gallatin County, Montana

Dear Members:

We the undersigned freeholders of Gallatin County, Montana taxable herein for road purposes do hereby petition the Board of County Commissioners, pursuant to section 7-14-2601, MCA to abandon a portion of Schutter Road and being more particularly described as follows:

Beginning at the northeast corner of section 12, Township 1 south, Range 2 east, which is also the point of beginning for the abandonment, thence south 5280 feet.

1. Total distance to be abandoned is 5280 feet.
2. Road to be abandoned is shown in red on the attached drawing.
3. The necessity for and the advantage of the petitioned action as described above is as follows:
 - a. Abandonment of this portion of Schutter Road will financially save Gallatin County tax dollars in the future.
 - b. Also, this will remove an unused dirt road from the County Road system.

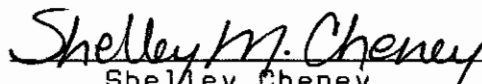
For Request For Abandonment Of A Portion Of Schutter Road

THIS RESOLUTION was introduced by Jane Jelinski,
Commissioner, moved by A. D. Pruitt, Commissioner, and
seconded by Deb Berglund, Commissioner. The resolution was
passed unanimously and adopted.
(unanimously or majority)

WHEREAS, a Petition to Abandon County Road was filed with the Gallatin County Clerk and Recorder requesting that a road commonly known as Schutter Road be abandoned; and

WHEREAS, the Gallatin County Clerk and Recorder reported to the Gallatin County Commissioners that the petition contained sufficient signatures as required by Section 7-14-2601, MCA; and

WHEREAS, a committee consisting of one county commissioner, the county surveyor and road supervisor convened to investigate the feasibility and desirability of abandoning the road; and

WHEREAS, the petition was filed before the adoption of the Gallatin County Road Abandonment Procedures on March 17, 1992; and

WHEREAS, on May 12, 1992, the Gallatin County Commissioners conducted a public hearing, after notice, on the petition and the results of the investigation.
