TO: THE BOARD OF COUNTY COMMISSIONERS, GALLATIN COUNTY,  
MONTANA

COMES NOW the undersigned, SAM GIANFRANCISCO, Gallatin County Road & Bridge Superintendent, and provides the following additional information and clarification pertaining to a "Petition to Abandon County Road", previously filed with the Clerk & Recorder concerning the abandonment of a portion of "Old Town Main Street" in Old Town.

The road to be abandoned is particularly described as follows: A portion of roadway referred to as: West Main Street, located in "Old Town", beginning on the west side of State Street at its intersection with West Main Street, proceeding in a westerly direction a distance of approximately 1200 feet (more or less), up to the point that said roadway intersects with Burlington & Northern Railway right-of-way.

The portion of said roadway proposed for abandonment would be a forty foot (40') strip of county right-of-way lying on the south side of "West Main Street". At present, Gallatin County has a one hundred foot (100') right-of-way on "West Main Street". If the foregoing proposed abandonment is approved, Gallatin County would still have a sixty foot (60') right-of-way on "West Main Street".

On October 21, 1993, the undersigned being duly appointed as viewing committee, viewed a portion of West Main Street located in "Old Town" of Three Forks in Section 24, Township 2 North, Range 1 East, M.P.M., Gallatin County, Montana, which has been petitioned to be abandoned.

County Road Superintendant Sam Gianfrancisco submitted an addendum to the viewing committee for clarification purposes of the petition.

The viewing committee observed the following:

1. There is currently a cinderblock garage which has been built on the 100 foot right of way. It appears that this building has been in place for approximately 30 years and encroaches on approximately 27 feet of the right of way.
2. It does not appear that any landowner would become landlocked, nor any access to public lands be denied if the petition were granted.
3. By abandoning 40 feet of the south side of the right of way, the County will still retain a 60 foot right of way which complies with current County Standards.

RESOLUTION NO. 1993- 44

**DECISION CONCERNING PETITION TO ABANDON COUNTY ROAD  
NAME OF COUNTY ROAD: PORTION OF MAIN STREET IN "OLD TOWN"  
THREE FORKS**

WHEREAS, a Petition to Abandon County Road was filed requesting that a portion of Main Street in "Old Town" Three Forks which is located in Section 24, Township 2 North, Range 1 East, M.P.M. Gallatin County, Montana and more particularly described as follows:

West Main Street, located in "Old Town", beginning on the west side of State Street at its intersection with West Main Street, proceeding in a westerly direction a distance of approximately 1200 feet (more or less), up to the point that said roadway intersects with Burlington and Northern Railway right-of-way.

WHEREAS, the Gallatin County Clerk and Recorder reported to the Gallatin County Commissioners that the petition contained sufficient signatures as required by Section 7-14-2601, MCA; and

WHEREAS, the Gallatin County Commissioners appointed a committee consisting of one county commissioner, the county surveyor and road supervisor to investigate the feasibility and desirability of abandoning the road; and

WHEREAS, on November 8, 1993, the Gallatin County Commissioners conducted a public hearing, after notice, on the petition and the results of the investigation.

NOW, THEREFORE BE IT RESOLVED:

1. Based on the petition, results of the investigation and information presented at the public hearing the Gallatin County Commissioners conclude that the decision made herein is in the best interests of the county for the following reasons:

a. There is currently a cinderblock garage which was built on the 100 foot right-of-way of the portion of the road to be abandoned. It appears that this building has been in place for approximately 30 years and encroaches on approximately 27 feet of the right-of-way.

b. It does not appear that any landowner will become landlocked.

c. Access to public lands will not be denied if the petition is granted.

d. The portion of the road to be abandoned is a forty foot (40') strip of county right-of-way lying on the south side of "West Main Street." At present, Gallatin County has

a one hundred foot (100') right-of-way on "West Main Street". By abandoning 40 feet of the sought side of the right-of-way Gallatin County will retain a 60 foot (60') right-of-way which complies with the current Gallatin County Standards.

2. The following road, as requested in the Petition to Abandon County Road, is abandoned:

A portion of Main Street in "Old Town" Three Forks which is located in Section 24, Township 2 North, Range 1 East, M.P.M. Gallatin County, Montana and more particularly described as follows:

West Main Street, located in "Old Town", beginning on the west side of State Street at its intersection with West Main Street, proceeding in a westerly direction a distance of approximately 1200 feet (more or less), up to the point that said roadway intersects with Burlington and Northern Railway right-of-way.

3. Within ten (10) days from the date that this resolution is adopted the Clerk and Recorder shall send a copy of this resolution by certified mail to all owners of land abutting on the road. The owners shall be those listed on the last county assessment roll.

4. The Clerk and Recorder shall notify the county road supervisor by furnishing a certified copy of this resolution to the supervisor.
