

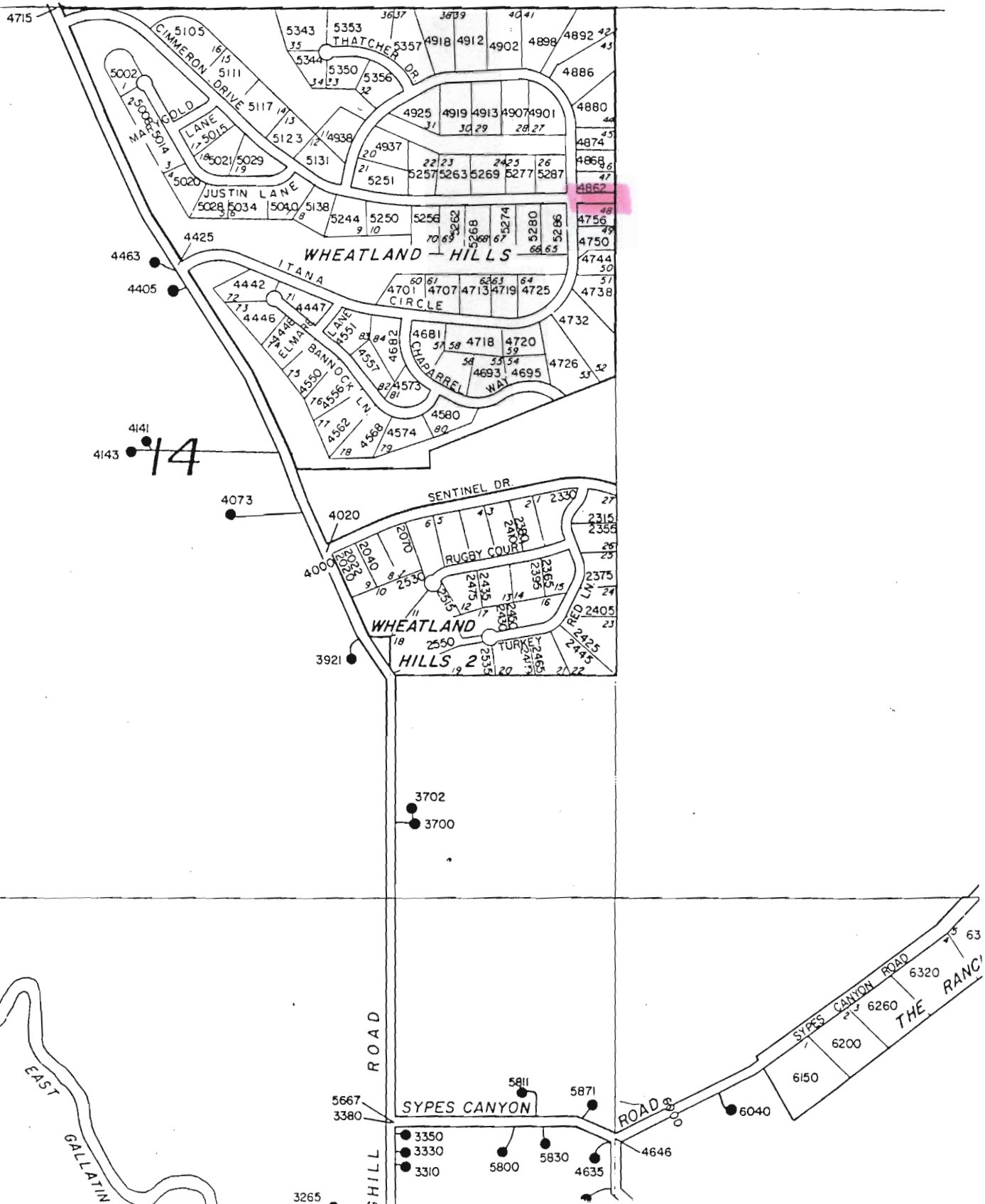

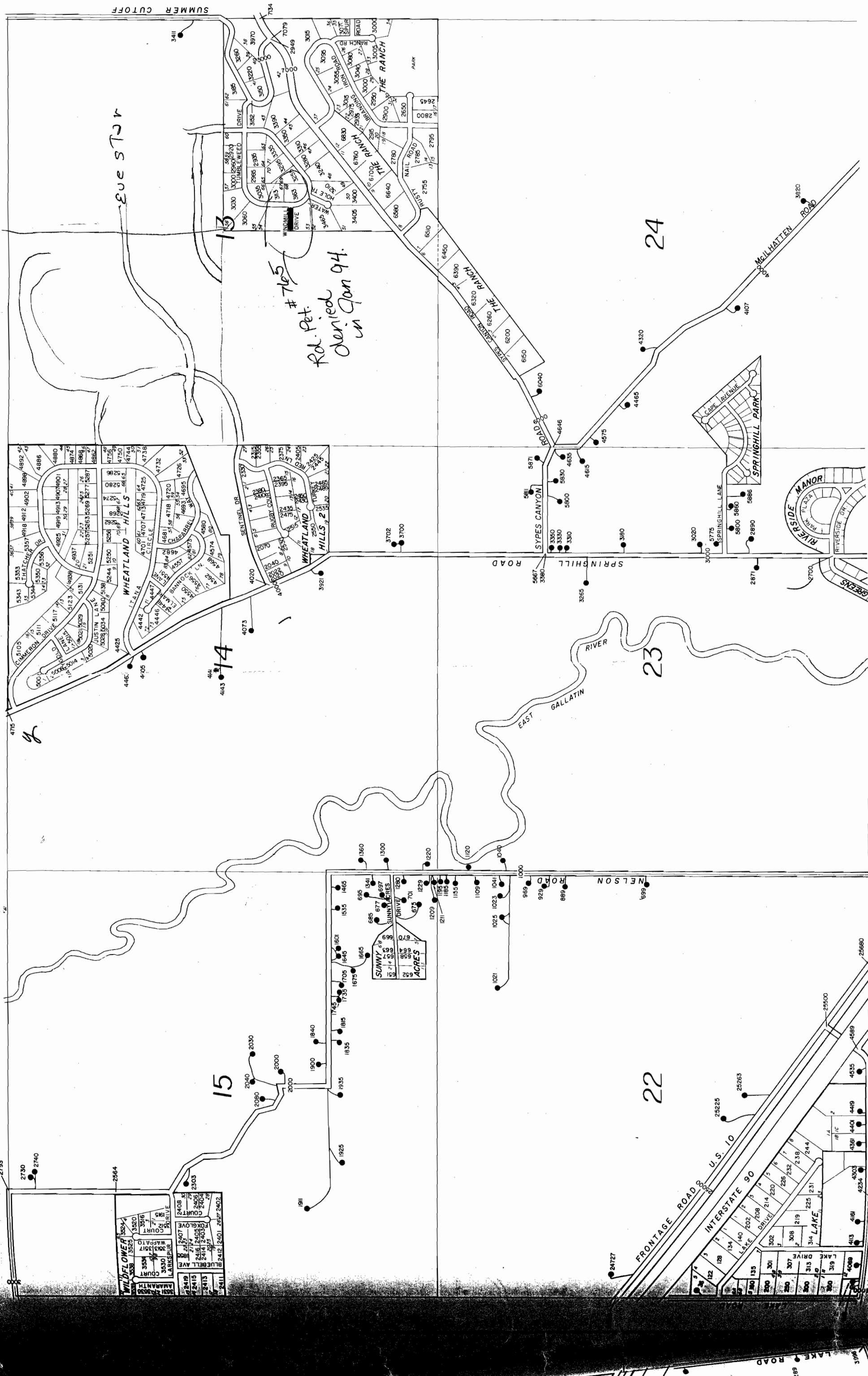

The undersigned Petitioners, for and on behalf of themselves and those surrounding homeowners similarly situated, hereby petition the Board of County Commissioners (hereinafter "Board") as follows: (1) for abandonment, pursuant to §7-14-2601, MCA, of the right-of-way easement which would connect the proposed Spirit Hills development with Cimmeron Drive in the Wheatland Hills Subdivision, other than for emergency vehicles and utilities access, and (2) that the Board reconsider and withdraw its July 18, 1995 preliminary approval of the 98-lot Spirit Hills Subdivision, pursuant to Section 3D6(d) of the Gallatin County Subdivision Regulations, since the determination is based on inaccurate information, and is not justified by the body of contrary evidence submitted, nor supported by the law and, in particular, since the Board's approval violates the review criteria set forth under §76-3-608, MCA.

1. The abandonment of said right-of-way easement is warranted on the following grounds:

a. On July 12, 1995, after having reviewed only a portion of the contrary evidence offered in this matter, the Gallatin County Planning Board unanimously voted that the proposed subdivision "did not meet public health and safety standards, as required by §76-3-608, MCA." In particular, the Planning Board found that "pedestrian travel on the access roads within Wheatland Hills would become more dangerous than it already is if this subdivision is approved, and that the additional traffic would make accidents more likely."

b. The July 18, 1995 testimony by the county's road and bridge superintendent, Sam Gianfrancisco, is highly inconsistent with, and simply belied by, his previous testimony expressing concerns over the advisability and feasibility of utilizing the Cimmeron Drive - Itana Circle access route. The superintendent's initial presentation alluded to problems inherent in the admittedly substandard design and construction of the Wheatland Hills roads. This calls into question whether the roads are capable of being altered or upgraded to meet appropriate county road standards to avert the potential threat to the safety of children and pedestrians as a natural and probable consequence of any such increase in traffic through the subdivision, and in potential violation of the very objectives concerning road safety expressed in Section 6E(1) of the Subdivision Regulations.

c. That the Cimmeron Drive - Itana Circle access routes do, in fact, fall short of the minimum paving and grade standards

for county and subdivision road design, as initially approved by the Board of County Commissioners on August 17, 1982, as revised and amended August 23, 1983, and as set forth in Sections 6 and 7 of the Subdivision Regulations, rendering the same nonconforming as a matter of law, and thereby obviating any additional burdening of the same through increased traffic of any kind.

d. The Board must re-evaluate the road and bridge superintendent's claim that it is mandatory for the subdivisions to be interconnected by common roads since the subdivision regulation in question, Section 6E(3), is purely directory, stating only that subdivisions be connected by common roads, "when such continuation is necessary" .... Moreover, the abandonment of this right-of-way easement for public travel would not, in any way, compromise or diminish the stated goals of "effective provision of emergency service, and efficient provision of utilities," as set forth thereunder.

e. The approval of said road connection essentially ignores certain aspects of the traffic impact study submitted by the developer, demonstrating that there will, in fact, be a dramatic increase in traffic through the Wheatland Hills No. 1 Subdivision and, consequently, a corresponding increase in potential safety hazards to inhabitants of Wheatland Hills and their children. The developer's revised traffic impact study, after he had obtained alternate access to Sentinel Drive to the south, is largely speculative, and does not dispel the fact that there will nevertheless be dramatic increases in traffic on the substandard roads in Wheatland Hills. Even assuming, arguendo,

there might be traffic mitigation of the nature claimed by the developer, Wheatland Hills will admittedly experience an increase in traffic volume of not less than 65% and, quite probably, much higher, since the Cimмерon Drive - Itana Circle route will undoubtedly be viewed and utilized as a type of shortcut for the adjoining subdivisions. Furthermore, it appears that the traffic study submitted on behalf of the developer was the only data of this kind actually considered by the Board in making its determination of preliminary approval.

f. In addition, the July 18, 1995 testimony of the county's road and bridge superintendent disregarded the potential use of Cimмерon Drive as emergency-only access. This is contradicted by other evidence, including the considered opinion of the Belgrade Fire Marshal, that the Sentinel Drive access may provide the best route for emergency vehicles into the Spirit Hills Subdivision -- particularly since the Sentinel Drive route would be situated closest to the new fire station, and would thereby provide a faster and safer response than the proposed Cimмерon Drive connection. Furthermore, even if the Cimмерon Drive access were to be used as an emergency-only/utilities easement, the proposed subdivision would nevertheless provide a "second access," within the meaning of Section 6E(9) of the Subdivision Regulations, vis-a-vis the alternate access to Sentinel Drive.

g. Finally, the Board's blanket approval of the subdivision, including the Cimмерon Drive access route, completely ignores the developer's unequivocal offer to forego and abandon

this route of access. Therefore, the determination by this Board must have been based on nothing more than the conclusory and inaccurate statements by the road and bridge superintendent regarding the subdivision regulations.

2. In the event the Board should deny this petition to abandon the proposed connection to Cimmeron Drive as a public right-of-way, Petitioners, for and on behalf of themselves and those homeowners similarly situated, hereby request that damages sustained by each owner thereon affected be determined and awarded pursuant to the mandate of §7-14-2607(1), MCA, and for any other reimbursements and assessments allowed by law and under Section 6 of the Subdivision Regulations.

3. In addition to the above, Petitioners' request that the Board reconsider and withdraw its overall decision to approve the Spirit Hills Subdivision, is based on the following grounds:

a. Substantial evidence demonstrates that the high density of the proposed development will also adversely impact water availability and cause increased potential for groundwater contamination from the installation of the additional septic systems. In this light, the Planning Board had unanimously determined, on June 12, 1995, that "the developer has not adequately demonstrated that the proposed individual septic systems would not create public health impacts upon groundwater quality." Furthermore, significant evidence, including the Erickson study, and previous concerns expressed by the Montana



Department of Health & Environmental Sciences, Division of Water Quality (now "DEQ"), demonstrate that the available information concerning sufficiency and continued quality of water is, at best, inconclusive. This is further evidenced by the fact that the conditional approval granted by the Department to the adjacent Summer Ridge Subdivision seriously questioned the available water supply, and envisioned the Spirit Hills development as no more than eight, 20-acre homesites.

b. In addition, it is Petitioners' position that the approval of the development, projecting many homes to be clustered on lots substantially less than one acre in size, not only violates the County's master plan by approving lot density completely incongruous with surrounding areas; but that the same will thereby undermine the aesthetic character of the area in contravention of the general zoning goals set forth under §76-2-301, MCA; the objective of "conformity" in design standards required under Section 6A(1) of the Subdivision Regulations and, inevitably, will detrimentally impact surrounding property values.

4. For all of the foregoing, Petitioners respectfully request:

a. That the Cimмерon Drive right-of-way be abandoned by official action. Upon abandonment, the aforesaid dedicated public right-of-way shall revert to the homeowners of Wheatland Hills as common area, open space, and which would then be granted to the County as an emergency vehicle/utilities easement.


b. Alternatively, and if for any reason said Petition for Abandonment is rejected, Petitioners hereby request an appropriate determination and award of damages for the diminution in value to their property, and that of similarly situated and affected homeowners, pursuant to §7-14-2607(1), MCA, and for such other reimbursements and assessments permitted by law and under the applicable Subdivision Regulations.



Finally, Petitioners request that the Board reconsider and withdraw its overall preliminary approval of the development, and thereby require the applicant to significantly lower the proposed density thereof to lessen the inevitable impacts on water quality, quantity and the aesthetic values hereinabove referenced.



On December 6, 1995, the undersigned, being appointed as viewing committee, viewed that portion of Cimmeron Drive as described in Road Petition #776, which is located within Wheatland Hills Subdivision.

During our review, we viewed Sentinel Drive located in Wheatland Hills Subdivision #2 where this road ends onto undeveloped land; Tumbleweed Drive located in Ranch Subdivision which used to end onto undeveloped land and currently connects into Summer Ridge Subdivision; Evening Star Lane located in Summer Ridge Subdivision which currently ends onto undeveloped land; Morningside Way located in Summer Ridge Subdivision which currently ends onto undeveloped land; the southern portion of Itana Circle between Cimmeron Drive and Springhill Road located in Wheatland Hills Subdivision; and all of Cimmeron Drive located in Wheatland Hills Subdivision. The portion of Cimmeron Drive which is petitioned to be abandoned has not been constructed at this time.

It does not appear that any landowner would become land locked, nor anyone denied access to public lands if this petition were granted.

Once the proposed Spirit Hills Subdivision is developed, traffic will increase in the adjoining subdivisions such as Wheatland Hills Subdivisions #1 and 2, Ranch Subdivision, and Summer Ridge Subdivision. The viewing committee believes that if this abandonment were granted, by eliminating one pattern of circulation, the traffic that would be eliminated from Wheatland Hills Subdivision #1 will increase onto the other subdivisions.


The conditions of approval for Wheatland Hills Subdivisions, The Ranch Subdivisions, Summer Ridge Subdivision, and many others, all required that future access to unsubdivided lands be provided to insure a pattern of circulation for the benefit of the residents of Gallatin County in the event that the unsubdivided lands are ever developed.


Dear Commissioners:

As a concerned citizen and parent, I was dismayed at the recent letter sent from your office concerning the abandonment of Cimmeron Drive as an access to the Spirit Hills Subdivision. Within the aforementioned letter, I saw no mention of the safety, health and welfare of the residents of the Wheatland Hills Subdivision. Basically, the letter contained information as to your committee's interpretation of the laws governing accessibility to adjoining subdivisions. Laws are made to keep away chaos and *to protect the public*. I have a few basic points that I would like you to consider in your decisions concerning Cimmeron Drive:

- Why during the discussion of the original proposal by Mr. Walker is there contained no reference to the fact that his proposed subdivision had only two entrances and therefore needed to get a third one?
- Why was Mr. Walker's revised proposal, which excluded Cimmeron Drive, deemed unpractical because he did not include a third entrance to his property when previous discussions did not? Sentinel Drive and Summer Ridge clearly meet the two access requirement.
- Why are *substandard county roads* in Wheatland Hills being considered safe for the residents of the Wheatland Hills subdivision and therefore acceptable for heavily increased road traffic?
- Why have the school busses in the past had difficulties in navigating the *icy hills of this subdivision* (many times calling the residents of the subdivision to help get the bus unstuck) and yet it is considered safe for heavily increased traffic? Imagine these same icy roads on steep hills and the impact of increased traffic to the pedestrians.
- Why does the concern for the **safety of the children** of this subdivision does not seem to be present in the discussions concerning abandonment of Cimmeron Drive? Afterall, children and adults have to use this road to get to other homes, plus it is the only possible route for children to walk to their bus. This road is even more hazardous to the children of the area because there are no shoulders and sides of the roads are steep and graveled.
- Why is the county unconcerned with the extreme likelihood of *severe accidents at the intersections* at Itana Circle/Springhill Road and Cimmeron Drive/Springhill Road?
- Why has the county not taken action to ensure that similar problems do not happen in future subdivisions?

I believe that you are elected public officials charged with **protecting the common good**. Why is it that the health and human safety of Wheatland Hills is being discounted in adherence to subdivision regulations that do not serve a practical purpose in this case. i.e.: two other accesses to Spirit Hills so therefore a third access via Cimmeron Drive is not needed. At this time you have the opportunity to solve a problem before a tragedy occurs in the Wheatland Hills subdivision. I pray that you realize that for the safety of our children you need to give approval for the abandonment of the Cimmeron Drive access to the Spirit Hills Subdivision. If you choose to allow this dangerous condition to develop, then whatever adverse effect is created will be on your consciences. I hope you do the right thing in this case and allow the Cimmeron access be closed or at the least allow the access on a limited emergency use only with some means utilized to prevent public usage. Your decision will involve extreme safety issues and possibly lives, so please look at all the available options at your disposal and make a determination which will not adversely affect the residents of Wheatland Hills.

I live in Wheatland Hills and am writing you in regards to the abandonment of Cimieron Dr. as a thoroughfare for the Ranch, Summer Ridge, & Spirit Hills subdivisions. This access- Cimieron, would become just that.

I've heard reports of 232 cars/day (just from Spirit Hills), coming up/down Cimieron. Your viewing committee, which has as a whole, has said, by abandoning Cimieron, it would be unfair to other accesses. Well, granting the access will be unfair to us, because the majority of traffic will use Cimieron, and ignore the others. So one access is getting swamped while the others will see decreases or mild increases.

On the safety issue, this is an accident waiting to happen. Last night on snow slicked roads, I nearly ran over three kids on sleds at the treacherous bottom of Cimieron Dr., coming down the hill. They sled in the middle of the street! There are no sidewalks, and kids also slide down the steeply sloped shoulders. Your going to have blood on your hands if you allow this traffic to increase. It scared the hell out of me. In the summer, kids sit, roller blade, play ball, and bike all over Cimieron and Itana Circle. At night it's doubly treacherous, without any lights, or shoulder border visuals.

I find it ironic that the Master Plan, or conditions of subdivision approval provide for future access, but you don't consider the safety of your towns residents. Please use common sense here and abandon this access. One or two developers want, it, hundreds of residents don't. You did a great service to this valley passing the water district, you can do another by granting the abandonment of Cimieron Drive.

Dear Commissioner:

The recent letter from Shelley Cheney containing the recommendations of the commission appointed viewing committee of the proposed Cimmeron Drive abandonment was irresponsibly incomplete. Once again, the commission is not facing the real issue being addressed by the Wheatland Hills residents. The issue, as stated over and over in past commission hearings, is about public safety. No where in the review committees report is there any mention of the adverse effects of opening Cimmeron Drive to through traffic from Mr. Walkers proposed Spirit Hills subdivision. There are several important facts that you need to be apprised of before you make your decision on abandonment on December 19th.

- 1.) Walker's traffic engineer's revised traffic study which includes the traffic pattern over Sentinal Drive and Summer Ridge, still projects an impact of an additional 232 trips a day over Wheatland Hills roads. This is a 65% increase in current traffic. This is likely a conservative estimate when traffic from Summer Ridge and Ranch Subdivisions discover the new straight shot to Springhill road.
- 2.) By the county road superintendent's own admission, the Wheatland Hills roads do not meet current county standards. The roads, according to Mr. Geofrancisco, being 24 feet wide could technically handle 6,000 trips a day. Our road superintendent does not inform you that the roads in Wheatland Hills have no shoulders, are steeply banked, and are at and over the maximum incline allowed for safety onto Springhill road. Additionally, the roads were never designed to be collector roads. The one overlay asphalt topping will not handle the additional proposed traffic increase.
- 3.) There are no sidewalks, shoulders, pedestrian walkways, or bike paths in this subdivision. All intra-neighborhood travel must be done on the roads to which you are now considering adding a 65% higher traffic load.
- 4.) There are no pulloff areas for school bus stops for our children to access the bus safely. Our children must walk on the roads to get to the bus collection points.
- 5.) The steep inclines on Cimmeron Drive and Itana Circle onto Springhill road are extremely dangerous in the winter. Numerous residents have slid off the steep shoulders into residents yards and others have slid out onto Springhill road since the landing areas are too short. An additional 232 cars a day will certainly create traffic hazards resulting in accidents.


Clearly you must see that we have serious reservations about increasing the traffic flow into an already unsafe situation. It is also clear that you can solve this overburdening problem. Cimmeron Drive is not needed as an access. Sentinal Drive is clearly the safest

route to Springhill with its flat access, however most people in Spirit Hills will utilize Cimmaron Drive since it is closer to the majority of the proposed lots in Spirit Hills. Summer Ridge creates the second egress/access to Spirit Hills. Most people will not take that route over to Sypes Canyon if Cimmaron Drive is opened. Why does this subdivision need three access points? Only two are required.

Subdivision regulations state that adjoining subdivisions " may " be connected by road if deemed necessary. This regulation does not make it an absolute necessity to connect subdivisions. In this case, the above mentioned reasons (1-~~5~~) should enter into your consideration of this issue. You have the opportunity to make a decision on December 19th that will have a very direct impact on the *health and safety* of all the residents of Wheatland Hills.

No one loses if Cimmaron is abandoned. Ken Walker, the Spirit Hills developer supports abandonment and all the residents of Wheatland Hills support abandonment. The Fire Chief for the Belgrade rural fire department concedes that Sentinal Drive provides the most direct, fastest access to Spirit Hills. No landowner would become land locked, nor anyone denied access to public lands if this petition were granted. Please do not blindly follow the recommendations of one county road superintendent who clearly does not concern himself with this county's citizens safety.

The purpose of this letter is to voice opposition to opening Cimмерon Drive as an access route for any additional subdivision.

Our concern centers on the issue of safety. Cimмерon Drive has a substantial slope, narrow shoulders, with a steep drop off to grade, and a dangerous intersection with Springhill Road.

At the present time with limited traffic, Cimмерon Drive provides adequate access for residents of Wheatland Hills. However, the current circumstances still require residents to drive at reasonable speeds and exercise extreme caution in inclement weather.

Any sizable increase in the number of vehicles on Cimмерon Drive during inclement weather will create a more dangerous situation and lead to vehicular accidents. Increased traffic also represents increased peril for school children walking road shoulders, as there is no room for sidewalks, to designated school bus stops.

The intersection of Cimмерon Drive and Springhill Road requires special attention. In inclement weather (i.e., snow, ice), this intersection is dangerous even when only one vehicle is travelling Cimмерon toward Springhill Road. This, due to the steep slope without any level landing area. Numerous accidents have occurred here. Increased traffic will radically alter the level of danger.

It is our understanding that Cimмерon Road does not meet current standards, as attested to by Mr. Sam Gianfrancisco during preliminary testimony this summer. We assume the reason that standards were established was to provide direction for the construction of roads that are safe. We cannot understand how the same body that created these standards can abandon them.

For the reasons aforementioned, we believe the appropriate course of action is to abandon the use of Cimмерon Drive for any other subdivision. Approval of the use of Cimмерon Drive as an access route would, in our opinion, constitute negligence.

I am writing concerning the petition to abandon the connection of Cimмерon Rd. to the subdivision proposed by Mr. Ken Walker. I encourage you to share my comments with the other Commissioners.


Having read the report submitted by the viewing committee of P. Olson and S. Cheney, I was dismayed to note a complete lack of understanding of the issues at the heart of this matter. The conclusion was particularly telling- they state that the abandonment would only be advantageous to residents of Wheatland Hills #1 subdivision. What they fail to mention is that we are also the only owners in the area with anything to lose! All of the residents of Summer Ridge, Walkers subdivision, and every other landowner that now uses Summer Cutoff will have a new access to Springhill Rd no matter where it is; Cimмерon and/or Sentinel. Wheatland Hills #2 will lose some, but Sentinel Rd does not cut through the middle of that subdivision, it is the access from their subdivision to Springhill Rd. The impact of an access via Sentinel on Wheatland Hills #2 residents will be the same as to many residents of Wheatland Hills #1- they will look down on more traffic traveling on Sentinel. It will not be a threat to their children who must walk, ride their bikes, and wait for the school bus on narrow, shoulderless roads, as will be the case with increased traffic on Cimмерon and Itana. It will not cause excess wear on substandard roads, as is the case with increased traffic on Cimмерon and Itana (assuming, of course, that the county makes sure that the roads are built to code this time!). It will not cause a drop in the property values of existing homes, as will happen if Cimмерon and Itana become thoroughfares for every resident uphill of Springhill Rd-there are few or no houses in any of these subdivisions that are being connected, so the value of the properties will reflect the expected traffic. This is not the case with us in Wheatland Hills, who are now being bushwhacked with this issue years after we bought our houses (for prices reflecting the level of traffic we assumed would remain constant).

I must say that I also have a hard time understanding the way this county handles its road issues, which may be typical of Montana but not other places I have lived. We paid for paving the roads in our subdivision, and will continue to pay for another 14 years. Will the people that will now routinely use the roads we paved contribute to lessen our debt? I do not think so. We pay for snow removal with subdivision dues. Will the new users contribute to that? I doubt it. The county now has the "responsibility" to maintain the roads, but we get charged an extra fee on our taxes to pay for that. Will the new users pay more to the county because they now use our roads on top of the fees they will be charged for the county to take care of theirs? I doubt it. So, it appears that the roads are totally our responsibility until it comes time to decide how the roads are used! **It just is not fair!**

In conclusion, in consideration of the safety and fairness issues involved, I urge you to vote for abandonment of this easement. The contractor, Mr. Walker, has professed that he does not want or need this access. A viable alternative has been identified, such that, as the viewing committee noted, no landowners would become landlocked or denied access to public lands. And, while the only ones to "merit" from this abandonment are the owners of Wheatland Hills, there is no one that will lose. And we in Wheatland Hills do have a lot to lose, regardless of the rather sterile, legalistic document prepared by the Viewing Committee.

I hope your reputation as a caring, reasonable Commissioner are correct.

I am writing to urge you to approve the abandonment of the unimproved section of Cimmeron Drive, located in Wheatland Hills Subdivision.

As a ten-year resident of the Subdivision, my primary concern is for the safety of the residents, pedestrians and motorists alike. Our roads are substandard as they exist, and any increase in traffic poses a threat to the safety of our residents.

I attended each Commission meeting last summer, which dealt with the Spirit Hills Subdivision. The residents of Wheatland Hills voiced a variety of legitimate concerns, which evidently were discounted by the Commission. While I do not intend to reiterate each concern, I feel very strongly that the Commission could and should approve the abandonment of the portion of Cimmeron Drive.

I question allowing the access to remain, not only for the safety issue, but the burden we must carry for the convenience of the developer. There is no compensation for the maintenance and snowplowing of the roads, which are being paid for by Wheatland Hills residents. There are no guarantees for upgrading the current road conditions to

accommodate an increase in traffic. I am not convinced that the traffic count projections are accurate to reflect the traffic which will actually use the Cimmeron access. It seems odd that without changing the Spirit Hills plan, that the majority of the traffic will automatically use the Sentinel Drive route.


Spirit Hill's developer , Ken Walker at one time owned the land which adjoins the north side of the proposed subdivision. It was his choice to not retain any access roads to the north. It is unfair that we should be encumbered by this decision.

Mr. Walker does not oppose the abandonment , why can't the Commission listen to the concerns of Wheatland Hills residents and vote for abandonment?

I invite you to visit the Wheatland Hills Subdivision on a snowy day ( should we ever receive the snow this week). Maybe then the picture would become more clear.

I appreciate your consideration and encourage you to vote for the abandonment of the undeveloped portion of Cimmeron Drive.

Dear Phil, Jane and Kris:

In response to the Notice of Public Hearing and to the viewing committee's letter dated December 7, 1995, we would like to offer the following:

1. Why are you requiring a third ingress/egress access to Spirit Hills when the developer has offered and agreed to the vacating of Cimmeron and your own Planning Board expressed concern about the safety/health aspects of using Cimmeron Drive? In fact, at an early meeting you expressed substantial concern relative to the safety issue on Cimmeron Drive.
2. The traffic study which indicated that approximately 232 additional trips per day would result if Cimmeron were used as an access seems low. If only the northern quadrant of Spirit Hills used Cimmeron Drive, this would include over 50 lots x 8 trips daily totaling 400 trips daily. This doesn't include use by property owners in Summer Ridge, Harvest Hills and areas north that potentially could use this access. As a Realtor, I have encountered on numerous occasions purchasers who would not purchase lots or homes in that area because of their concern over the steep grade of Summer Cutoff Road. An access through Wheatland Hills via Cimmeron & Itana Circle would alleviate much of that concern and would also allow for substantially increased traffic over these streets.
3. The roads in Wheatland Hills do not meet county specifications; i.e., no shoulders, steep side shoulders, only 1.5" asphalt, and a landing area on Cimmeron and Itana Circle that is much too short, particularly when the roads are icy. In addition, Wheatland Hills homeowners, who currently maintain the subdivision roads, should not be asked to maintain what would amount to a collector or arterial road to Spirit Hills/Summer Ridge/Harvest Hills if this request for vacating is not approved.

In summary, we feel that you do need to consider the needs of all constituents in Gallatin County; however, that should include those in Wheatland Hills as well. The safety issue is of paramount concern. We would hate to see the first death or injury on these roads result in an adverse action against you or the County.

Thank you for your sincere consideration of this matter. Please vacate the north portion of Cimmeron Drive adjacent to Spirit Hills.

Dear Commissioners:

I urge you either to approve the abandonment of that portion of Cimмерon Drive affected by Road Petition #776 or, alternatively, to impose such conditions as will prevent general traffic from using that portion of Cimмерon Drive.

The viewing committee believes this action will only benefit Wheatland Hills #1. However, the denial of the petition will mean that a number of other subdivisions will benefit at the sole expense of Wheatland Hills #1, for Wheatland Hills #1 will bear the majority of traffic coming out of Spirit Hills Subdivision, Ranch Subdivision, Summer Ridge Subdivision, and other residences to the east to access Springhill Road.

In fact, the pattern of traffic circulation that would result if the petition is approved will benefit everyone, for there would be staggered and varied accesses onto Springhill Road from the various growing developments in the area, rather than having the majority of that traffic access Springhill Road through Wheatland Hills subdivision #1, which will happen if the petition is not granted.

A crucial fact in your decision-making should be the condition of Itana Circle and Cimмерon Drive in Wheatland #1 and their inability to handle the significant increase in traffic that will surely flow down them if access to Cimмерon Drive is available from the east. Neither Cimмерon Drive nor Itana Circle was built to accommodate more traffic than each presently serves. Each is a narrow and steep road which is especially treacherous in the winter months. Neither meets county standards. Each provides a principal walkway, runway, and play area for children, pets, and adults in the area. They are the only avenues available for pedestrian, bike, tricycle, and wagon traffic in Wheatland Hills #1. A lot of that use is by preschoolers and grade schoolers. Those roads cannot safely accommodate the tremendous increase in traffic that will come if general access across Cimмерon Drive is allowed. The lives of children and of pets will be subject to much greater risk if the petition is disapproved or if Cimмерon Drive goes through.

The interests of public safety and effective traffic circulation to Springhill Road both favor the petition. Access to public land or to lands to be developed later will not

be denied or made difficult as a result.

One last point. Wheatland Hills #1 residents will pay \$260,000, plus interest, for Cimieron Drive, Itana Circle, and related roads via the Wheatland Hills #1 RSD #342. If you decide to permit residents of other subdivisions to use these roads, it is only fair that the approval be conditioned upon the additional users paying their fair share for the roads in Wheatland Hills #1 they will be using.



WHEREAS, on November 14, 1995; November 28, 1995; December 19, 1995; September 23, 1996; and October 8, 1996; the County Commissioners conducted public hearings, after notice, on the petition and the results of the investigation.

NOW, THEREFORE BE IT RESOLVED:

1. Based on the petition, results of the investigation and information presented at the public hearing, the Gallatin County Commissioners conclude that the decision made herein is in the best interests of the county to not abandon the portion of Cimmeron Drive located between lots 47 and 48 of Wheatland Hills Subdivision.

2. The Commission, at a hearing held in conjunction with the Petition to Abandon, changed the conditions of Spirit Hills Subdivision eliminating the paving requirement of that portion of Cimmeron Drive.

3. The Commission requested the County Road Superintendent re-evaluate the road in three to five years.

4. The Commission committed to paying for the construction of that portion of Cimmeron Drive if, after notice to the homeowners in Wheatland Hills I, Wheatland Hills II and Spirit Hills, it is determined that the road requires paving.

5. Within ten (10) days from the date that this resolution is adopted the Clerk and Recorder shall send a copy of this resolution by certified mail to the owners of land. The owners shall be those listed on the last county assessment roll.

6. The Clerk and Recorder shall notify the county road supervisor by furnishing a certified copy of this resolution to the



supervisor.
