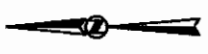

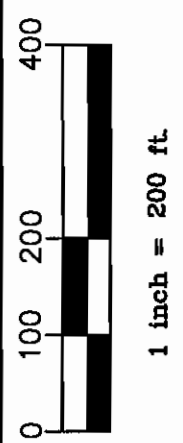

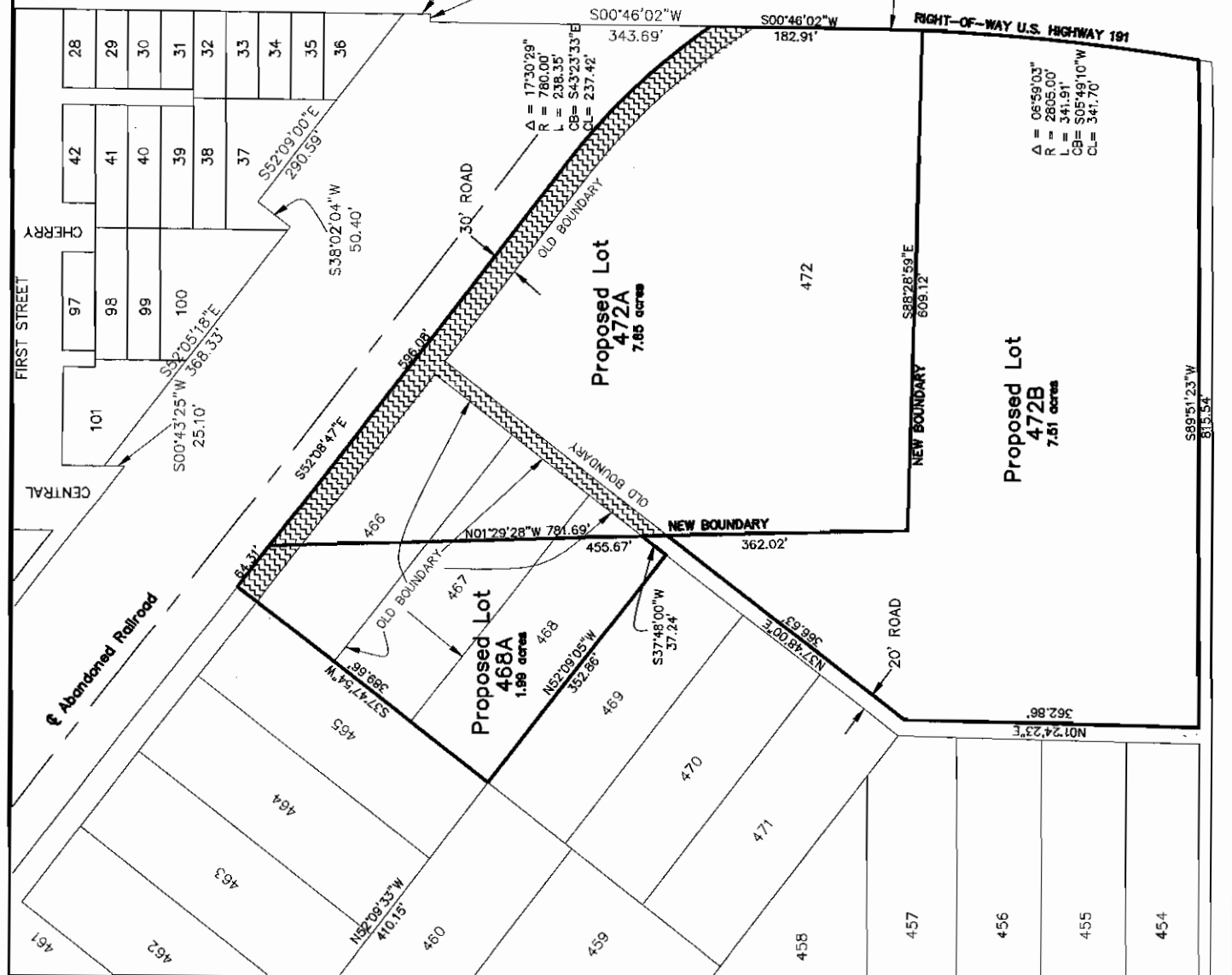

## RESOLUTION NO. 1998 - 33

**DECISION CONCERNING PETITION TO ABANDON COUNTY ROAD,  
A PORTION OF ROADS IN RAINBOW SUBDIVISION**

WHEREAS, a Petition to Abandon County Road was filed requesting to abandon two road easements described as that 30 foot wide road right-of-way which is adjacent to the north lot line of Lots 466 and 472 and parallels the abandoned railroad right of way for approximately 660 feet; and also that 20 foot road right-of-way located between Lots 466, 467, 468 and 472 of Rainbow Subdivision for approximately 323 feet; and

WHEREAS, on March 28, 1998, the Gallatin County Clerk and Recorder reported to the Gallatin County Commissioners that the petition contained sufficient signatures as required by Section 7-14-2601, MCA; and

WHEREAS, the Gallatin County Commissioners appointed a committee consisting of one county commissioner, the county surveyor and the road supervisor to investigate the feasibility and desirability of abandoning the road; and

WHEREAS, on April 28, 1998, the Gallatin County Commissioners conducted a public hearing, after notice on the petition and the results of the investigation; and

WHEREAS, the Gallatin County Commissioners voted unanimously to grant the petition and abandon the two road easements in Rainbow Subdivision as described above; and

WHEREAS, the County Commission determined, based upon the facts all adjacent lots are under the same ownership, Charles Page individually or as part of Aim Inc., determines that the abandoned portions of road easements should revert to Mr. Page.

**NOW, THEREFORE BE IT RESOLVED:**

1. Based on the petition, results of the investigation and information presented at the public hearing on April 28, 1998, the Gallatin County Commissioners conclude that the decision made herein is in the best interests of the county.

2. The following road as requested in the Petition to Abandon County Road is abandoned:

The two road easements described as that 30 foot wide road right-of-way which is adjacent to the north lot line of Lots 466 and 472 and parallels the abandoned railroad right of way for approximately 660 feet; and also that 20 foot road right-of-way located between Lots 466, 467, 468 and 472 of Rainbow Subdivision for approximately 323 feet.

3. The abandoned portions of road easement shall revert to

Charles Page individually and through his interest in Aim, Inc.

4. Within ten (10) days from the date that this resolution is adopted the Clerk and Recorder shall send a copy of this resolution by certified mail to all owners of land abutting on the road. The owners shall be those listed on the last county assessment roll.

5. The Clerk and Recorder shall notify the county road supervisor by furnishing a certified copy of this resolution to the supervisor.
