RE: abandonment of a portion of Fir Street in the Northern Pacific Addition to Logan located between Railroad Street and River Street.

Dear Board,

The undersigned, being appointed as viewing committee, viewed the area described to be abandoned in Road Petition No. 795 on August 4, 1999.

The viewing committee located survey pins placed by surveyor Ron Allen on the southern corners of Lots 1, 2, and 3 of Block 4 of Northern Pacific Addition to Logan. A road is constructed to the west of the lots and is marked as Fir Street. Four power poles are located between the lots and the constructed road and run in a north/south direction.

Pine Street is not constructed. A power pole is located on the west side of the platted Pine Street.

The viewing committee took measurements from the survey pins to a power pole (which stands next to a utility phone box numbered 11155) and found that the power pole is actually located on the west side of the platted Fir Street.

The distance from the east side of the power pole to the west side of the constructed Fir Street is 28 feet. The actual gravel surface of the constructed Fir Street is approximately 15 feet wide.

Thus, it appears that the public park and Fir Street are constructed 50 feet west of their platted locations. Which means, constructed Fir Street is located within the platted public park. The garage owned by the Rutledges and a house owned by Whitneys is located on the platted portion of Fir Street.


No one would become land-locked nor denied access to public lands if this abandonment were approved. However, the alley will become a dead-end alley.

If Fir Street is abandoned it will not be maintained by the County. If the Commission grants the abandonment of Fir Street, the viewing committee recommends that the Commission have an amended plat prepared and recorded so that the public record is accurate.



DECISION CONCERNING PETITION TO ABANDON A PORTION OF FIR STREET IN THE NORTHERN PACIFIC ADDITION OF LOGAN

This Resolution was introduced by Susan Swimley, Chief Deputy County Attorney; moved by Commissioner Mitchell and seconded by Commissioner Murdock. The Resolution was adopted unanimously.

WHEREAS, on July 27, 1999, the Gallatin County Clerk and Recorder presented a Petition to Abandon that portion of Fir Street in Logan, Montana which is located in the Northern Pacific Addition to Logan between Railroad Street and River Street; and

WHEREAS, on July 27, 1999, the Gallatin County Clerk and Recorder reported to the Gallatin County Commissioners that the petition contained sufficient signatures as required by Section 7-14-2601, MCA; and

WHEREAS, on July 27, 1999, the Gallatin County Commissioners appointed a committee consisting of one county commissioner, the county surveyor and the representative the Gallatin County Road Department to investigate the feasibility and desirability of abandoning the road; and

WHEREAS, on October 12, 1999, the Gallatin County Commissioners conducted a public hearing, after notice, on the petition and the results of the investigation; and

WHEREAS, the Gallatin County Commissioners voted unanimously to grant the petition and abandon of that portion Fir Street in Logan, Montana which is located in the Northern Pacific Addition to Logan between Railroad Street and River Street; and

WHEREAS, Gary Rutledge and Rene Whitney offered to pay for the cost of a survey and the filing of an amended plat if the portion of Fir Street is abandoned; and

WHEREAS, the County Commission determined, based upon the fact that Fir Street was dedicated by the filing of the plat, filed in the Office of Clerk and Recorder on January 18, 1896, and the plat granted and donated the streets to the public forever and a house and garage are build in the dedicated right-of-way and the traveled portion of Fir Street is located within the park dedicated to the public and is signed and maintained as Fir Street, that abandonment of that portion of Fir Street between Railroad Street and River Street in the Northern Pacific addition of Logan is feasible.

NOW, THEREFORE BE IT RESOLVED:

1. On October 12, 1999, based on the petition and the results of the investigation, the Gallatin County Commissioners conclude that the decision made herein is in the best interests of the county.




