WHEREAS, on February 11, 2008, the Gallatin County Clerk and Recorder received a Petition, signed by at least ten freeholders in Gallatin County, to abandon a portion of an unnamed road dedicated on the plat of Adam's Investment Company's First Subdivision, pursuant to Title 7, Chapter 14, Part 26, Montana Code Annotated; and

WHEREAS, Section 7-14-2601(2)(b), MCA, defines the term "abandonment" to mean the cessation of use of a right-of-way (easement) or activity thereon with no intention to reclaim or use again; and

WHEREAS, the landowners immediately adjacent to the unnamed road have consented to its abandonment; and

WHEREAS, Section 7-14-2603, MCA, authorizes the Gallatin County Board of County Commissioners ("Commission") after considering the Petition and the results of an investigation, to make an entry on the minutes regarding its decision of whether to grant a Petition to abandon a county road; and

WHEREAS, the unnamed road is described as a portion of the dedicated 50' wide road located between Lots 12 and 13 of Adams Investment Company's First Subdivision situated in the NW1/4 Section 35 T2N, R1E P.M.M., Gallatin County Montana; and

WHEREAS, on March 12, 2008, the Gallatin County Clerk and Recorder certified that the Petition contained sufficient signatures as required by Section 7-14-2601, MCA; and

WHEREAS, on March 25, 2008, the Gallatin County Clerk and Recorder presented the Petition to abandon portion of an unnamed road dedicated on the plat of Adam's Investment Company's First Subdivision to the Commission and the Commission appointed a viewing committee consisting of one County Commissioner and the County Surveyor, as required by Section 7-14-2603(1), MCA; and

WHEREAS, on June 10, 2008, the viewing committee reported to the Commission that in looking at Adam's Investment Company's First Subdivision, the committee drove completely around the property, and determined that the street does not exist and would not deny access to any of the neighboring properties; and

WHEREAS, on June 10, 2008, the viewing committee reported no one would become landlocked nor denied access to public lands if the Petition were granted and that the viewing committee believes it is feasible and desirable to grant the Petition; and

WHEREAS, a Notice of Public Hearing was published in the Bozeman Daily Chronicle on June 22, 2008; and

WHEREAS, on June 24, 2008, the Commission conducted a public hearing, after notice, on the Petition and the results of the viewing committee's investigation; and

WHEREAS, on June 24, 2008, the Commission found that granting the Petition and abandoning the portion of an unnamed road dedicated on the plat of Adam's Investment Company's First Subdivision in Gallatin County, Montana would serve the best interests of Gallatin County; and

WHEREAS, the Commission determined the portion of the unnamed road dedicated on the plat of Adam's Investment Company's First Subdivision would no longer be used for public purposes, abandonment will not create a public safety hazard, and no person would be denied access or become land-locked, and that abandonment of that portion of right-orway is feasible; and

WHEREAS, the Commission voted unanimously to grant the Petition and abandon the portion of the dedicated 50' wide road located between Lots 12 and 13 of Adams Investment Company's First Subdivision situated in the NW1/4 Section 35 T2N, R1E P.M.M., Gallatin County, Montana.

NOW, THEREFORE BE IT RESOLVED:

- 1. The unnamed road dedicated on the plat of Adams Investment Company's First Subdivision, a portion of the dedicated 50' wide road located between Lots 12 and 13 of Adams Investment Company's First Subdivision situated in the NW1/4 Section 35 T2N, R1E P.M.M., Gallatin County, Montana, as requested in the Petition, is hereby abandoned.
- 2. The owner(s) of Tract 12 of Adams Investment Company's First Subdivision shall obtain all right, title, and interest to the west twenty five (25) feet of said unnamed roadway; the owner(s) of Tract 13 of Adams Investment Company's First Subdivision shall obtain all right, title and interest to the east twenty five (25) feet of said unnamed roadway.
