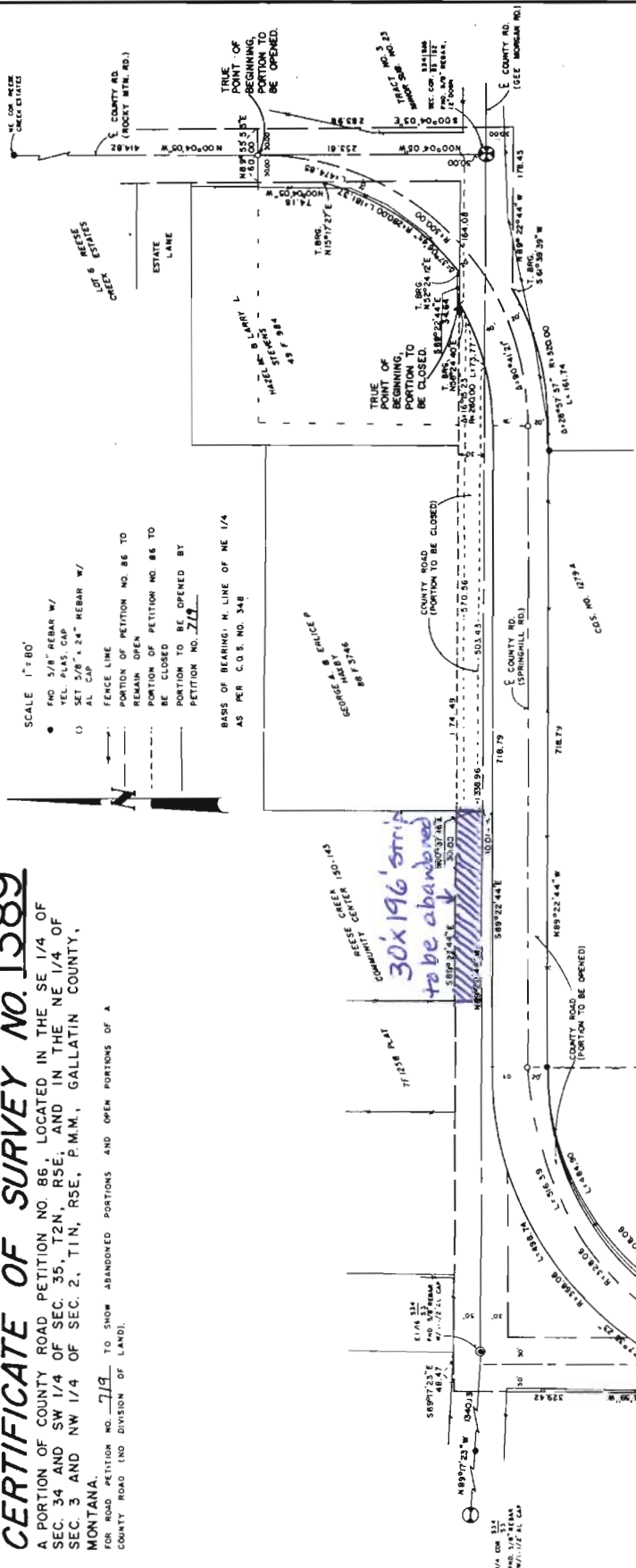

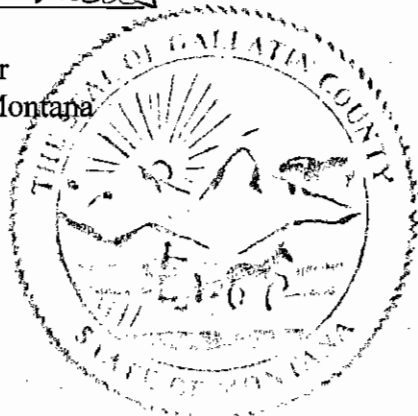

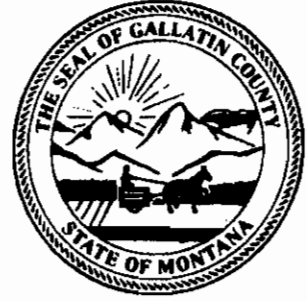

The properties on either side of the community center have fenced their section of the road abandoned, and it is difficult to see where the road was.

It is our conclusion that no one would be land-locked, nor denied access to public lands if the abandonment of this alley were granted. The viewing committee believes that it is feasible and desirable to grant the petition.

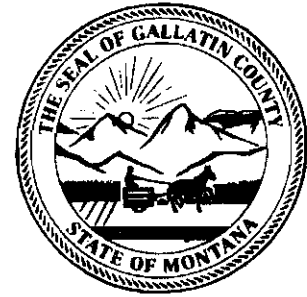

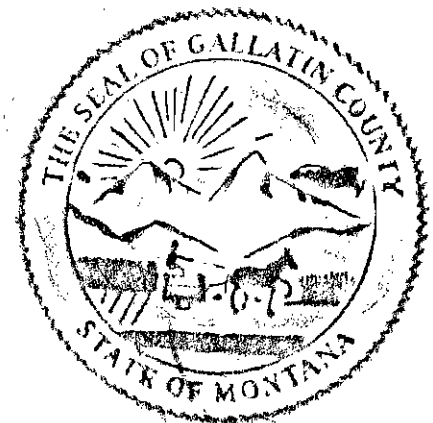

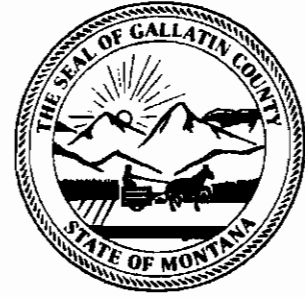

RESOLUTION NO. 2008-145

A RESOLUTION TO ABANDON A PORTION OF OLD MORGAN ROAD OR OLD SPRINGHILL ROAD ACCORDING TO ROAD PETITION NUMBER 826.

This Resolution was introduced by Charlotte Mills; moved by Commissioner Skinner and seconded by Commissioner White. The Resolution was adopted unanimously.

WHEREAS, on August 19, 2008, the Gallatin County Clerk and Recorder received a Petition, signed by at least ten freeholders in Gallatin County, to abandon a portion of Old Morgan Road or Old Springhill Road, pursuant to Title 7, Chapter 14, Part 26, Montana Code Annotated; and

WHEREAS, Section 7-14-2601(2)(b), MCA, defines the term "abandonment" to mean the cessation of use of a right-of-way (easement) or activity thereon with no intention to reclaim or use again; and

WHEREAS, the landowners immediately adjacent to the portion of the road to be abandoned have consented to its abandonment; and

WHEREAS, Section 7-14-2603, MCA, authorizes the Gallatin County Board of County Commissioners ("Commission") after considering the Petition and the results of an investigation, to make an entry on the minutes regarding its decision of whether to grant a Petition to abandon a county road; and

WHEREAS, the road is described as a Thirty (30) foot by One Hundred and Ninety Six (196) foot strip of land in Township 2 North (T2N) Range Five East (R5E) Section Thirty Four (34) directly adjacent to the southerly boundary of that tract of land recorded at Book 150 Page 143 of the Gallatin County Clerk and Recorder; and

WHEREAS, on September 8, 2008, the Gallatin County Clerk and Recorder certified that the Petition contained sufficient signatures as required by Section 7-14-2601, MCA and was assigned County Road Petition Number 826; and

WHEREAS, on September 17, 2008, the Gallatin County Clerk and Recorder presented the Petition to Abandon the portion of Old Morgan Road or Old Springhill Road to the Commission and the Commission appointed a viewing committee consisting of one County Commissioner and the County Surveyor, as required by Section 7-14-2603(1), MCA; and

WHEREAS, on November 14, 2008, the viewing committee reported to the Commission that they met to view the dedicated road being petitioned for abandonment on Friday October 24, 2008. They drove to the Reese Creek Community Center to view where

the road once was. The properties on either side of the community center have fenced their section of the road abandoned, and it is difficult to see where the road was; and

WHEREAS, on November 14, 2008, the viewing committee reported no one would become landlocked nor denied access to public lands if the Petition were granted and that the viewing committee believes it is feasible and desirable to grant the Petition; and

WHEREAS, a Notice of Public Hearing was published in the Bozeman Daily Chronicle on November 23 and 30, 2008; and

WHEREAS, on December 2, 2008, the Commission conducted a public hearing, after notice, on the Petition and the results of the viewing committee's investigation; and

WHEREAS, on December 2, 2008, the Commission found that granting the Petition and abandoning the portion of the Old Morgan Road or Old Springhill Road directly adjacent to the southerly boundary of that tract of land recorded at Book 150 Page 143 in the records of the Gallatin County Clerk and Recorder would serve the best interests of Gallatin County; and

WHEREAS, the Commission determined the portion of the Old Morgan Road or Old Springhill Road would no longer be used for public purposes, abandonment will not create a public safety hazard, and no person would be denied access or become land-locked, and that abandonment of that portion of right-of-way is feasible; and

WHEREAS, the Commission voted unanimously to grant the Petition and abandon the portion of Old Morgan Road or Old Springhill Road in Gallatin County, Montana described as a Thirty (30) foot by One Hundred and Ninety Six (196) foot strip of land in Township 2 North (T2N) Range Five East (R5E) Section Thirty Four (34) directly adjacent to the southerly boundary of that tract of land recorded at Book 150 Page 143 of the Gallatin County Clerk and Recorder.

**NOW, THEREFORE BE IT RESOLVED:**

1. The portion of Old Morgan Road or Old Springhill Road in Gallatin County, Montana described as a Thirty (30) foot by One Hundred and Ninety Six (196) foot strip of land in Township 2 North (T2N) Range Five East (R5E) Section Thirty Four (34) directly adjacent to the southerly boundary of that tract of land recorded at Book 150 Page 143 of the Gallatin County Clerk and Recorder, as requested in the Petition, is hereby abandoned.

2. The owner(s) of the tract of land recorded at Book 150 Page 143 of the Gallatin County Clerk and Recorder shall obtain all right, title, and interest to the thirty (30) foot by One Hundred and Ninety Six (196) foot strip of land of said abandoned roadway;


