PETITION FOR ROAD.

To the Honorable Board of County Commissioners, Gallatin County,

THE Undersigned, your petitioners, citizens of the United States, respectfully show and represent that they are Householders of the County of Gallatin, in the state of Montana, and that they reside in the vicinity where the road hereafter petitioned for is to be located, laid out and established if this petition be granted. That the proposed road will be a public convenience, and we think, the public good requires it.

Four petitioners do respectfully ask and petition your Honorable Body to lay out, locate and establish a County road sixty feet in width, to be a public highway, as follows, viz: Commencing, at starting point of such road, at ~~a~~ ^a point where the Northern Pacific Rail Road crosses the Township line of the Townships No. 1. N. of No. 4. E. & one N. of No. 3. E. on the line of the N. W. 1/4 of Sec 19 in T. 1. N. 4. E. and the N. E. 1/4 of Sec 24. in T. 1. N. R. 3. E. ^{to near 40, marked} Then following said Township line south through sections 25, 30, and 36, & 34, until it intersects the road running East & West on said Township line. All of said lands being in Towns 1 N. R. 3. E. 4. E. in Gallatin Co and state of Montana
